


Objection No.1 :- Against column No. A(2) (xiii), the legal status of the user agency has been mentioned as Central Government, whereas the user agency in the present proposal is State Govt. Necessary correction is required to be made against this column.

Reply:- The proposed project is under the Central Govt. and Budget/ Functioning of above project is under Central Govt. but State Govt. has given the land with free from all encumbrance / NOC from all department. So land diverted to Central Health Department and ADM Bilaspur authorized as User Agency and Designated as ADM cum Dy. Director AIIMS (Admin) Vide Letter No. HFW-B(B)1-7/2016 dated 13/08/2018 on the behalf of HP Govt. to Central Department.
