In compliance of the Ministry of Environment and Forests (MoEF), Government of India's Letter No.11-9/98-FC(pt) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February-2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 3.43HA of forest land proposed to be diverted in favour of Executive Engineer, PR Division Bhadrachalam for diversion of forest land to an extent of 3.43HA for Widening and upgradation PWD Road Mondikunta to Mamillavai in Aswapuram Mandal of Bhadradi Kothagudem District under LWE Pradhan Mantri Gram Sadak Yojana norms.
