

Revised Demand Notice.

Sub : Diversion of 9.40 Ha Forest Land in R.M.Block, Sandur North Range, For use of approach road in favour of M/s Zeenath Transport Company, Bellary District Reg.

With reference to the above subject, you not having permission use the approach road outside the leased within forest area over an extent of 9.40 ha, where as you have been submitted the proposal for FC clearance online. Principal Chief Conservator of Forests (HoFF), Bangalore in his letter cited reference (3) above, has referring letter of Forest, Ecology & Environment, Govt. of Karnataka Bangalore in respect of six mining leases may be permitted to make use of the existing roads outside the lease area but within adjacent forest areas by imposing certain conditions.

Hence, as per the conditions imposed by the Principal Chief Conservator of Forests (HoFF), Bangalore this office issued demand notice vide reference(4) above as follows :


