

POWER OF ATTORNEY

NOW KNOW YE ALL AND THESE PRESENTS WITNESSETH THAT, we **RELIANCE JIO INFOCOMM LIMITED**, a Company incorporated under the Companies Act, 1956, having its Registered Office at 3rd Floor, Maker Chambers IV, 222, Nariman Point Mumbai – 400021, Maharashtra (hereinafter called the "Company"), doth hereby nominate, constitute and appoint **SHRI B.M.S. THIS POWER OF ATTORNEY shall be deemed to have commenced with effect from the date of execution of these present and shall cease to have effect on 31st October, 2014 or on the date on which, the Attorney ceases to be associated with the company, whichever is earlier, and the acts, deeds and things done by the said Constituted Attorney during this period are valid and binding on the Company.
