In continuation to the above subject, Permission in an area of 189.6808 ha forest land in Kagaznagar, Asifabad & Bellampally divisions for execution of various engineering works for laying of new third BG Railway line along the existing tracks within the railway boundary between Makudi and Rechni road railway stations is required under the Forest (Conservation) Act, 1980 and Wildlife (Protection) Act, 1970.

As per the ETS & DGPS/GNSS survey data of forest land verified and authenticated vide letter under Ref-6, the required sets of proposals i.e. 8 sets for each division of F(C)A (Kagaznagar, Asifabad & Bellampally) under RF areas and 18 sets for each division (Kagaznagar) in WL format are submitted herewith for further process please.

This project is being monitored by Hon'ble Prime Minister's office and included in Pragathi Project. In view of this, it is requested that early action may be taken in regard to issuance of necessary permissions required under the Forest (Conservation) and Wildlife (Protection) Acts.
