With reference to above, this is to inform you that the Compensatory Afforestation Scheme over 120.838 ha. of non-forest Govt. land identified in village Podadihi under Keonjhar Division has been revised and approved by the Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, F.C. Act' O/O the P.C.C.F., Odisha, Bhubaneswar for ₹3,15,84,200/- @ ₹303.40 per MD which includes ₹35,44,597/- towards cost of Site Specific SMC 25% of the C.A. cost as per Condition No.(iii) of the Stage-I approval vide his Memo No.15865 dt.10.9.2020.

Further, vide Letter No.002 dt.29.1.2020 and Letter dt.1.9.2020, you have intimated the undersigned that you have already deposited ₹3,11,76,400/- (₹2,63,49,000/- + ₹48,27,400/-) towards cost of Compensatory Afforestation through e-portal of MoEF & CC as provided in the <http://parivesh.nic.in>.
