Sub:- Grant of Mining Lease in the District of Sundargarh.

Read:- Application presented on 23.10.2000 by M/s. MGM Minerals Ltd. for grant of Mining Lease over an area of 28.397 hecsts.. in village-Patabeda in the district of Sundargarh.

Order :

Whereas. M/s. MGM Minerals Ltd. applied to the State Govt. for grant of a Mining Lease by their application read above ;

Whereas the mineral in the land in respect of which the Mining lease has been applied for belongs to Govt. and the land is at their disposal ;

Whereas the applicant(s) being a Limited Company is incorporated or registered in Indian ;

Whereas the applicant(s) by themselves or with any person joint in interest with them do not in respect of Iron ore or related group of minerals held such area in the State as with the area over which the ML has now been asked for will exceed ten square kilometres in the aggregate;

Whereas the Govt. of India in their letter No.5/22/2001-MIV dt.26.9.2001 have conveyed their approval to the grant of M.L. under Section-5(1) of the M>M>(D&R) Act, 1957 over 28.397 hecsts.;

Whereas MOEF, Govt. of India have conveyed their approval U/s.-2 of F.C. Act, 1980 for diversion of forest land over 23.581 hecsts. involved within lease area vide their letter No.8(21)28/2003-FCE. Dt.30.12.2005 ;

Whereas the party was asked in this Department letter No.11533 dt.3.10.2001 to accept the terms and condition under which the ML was proposed to be considered for grant and the party in their letter dated 4.10.2001 accepted those conditions ;

Therefore, the State Govt. are hereby pleased to order that a ML in respect of the area over 28.397 hecsts. in village-Patabeda in the district of Sundargarh be granted to M/s.MGM Minerals Ltd. for a period of 20 (twenty) years subject to the conditions laid down in the State Govt. letter No.11533 dt.3.10.2001. The party should comply with all the terms and conditions including furnishing of a surveyed map and description within 3(three) months from the date of this order to the Collector, Sundargarh.
