It is to inform that, in the reference 1st cited, the Government of India have accorded In-principal (Stage-I) approval under Forest Conservation Act 1980 for diversion of **4.43** ha forest land for laying of 16" Dia VDPL Pipeline route from Vijayawada to Chittoor (W) in favour of HPCL existing in Krishna, Guntur, Prakasham, Kadapa and Chittoor subject to the conditions stipulated therein

Therefore the General Manager, M/s Hindustan Petroleum Corporation Limited (HPCL), Bangalore is requested to deposit the following mentioned amount towards Compensatory Afforestation, Net Present Value etc. through e-payment mode i.e. challan generated through the Ministry's website portal (i.e. www.forestclearance.nic.in) in Adhoc-CAMPA as per the guidelines issued by the Adhoc-CAMPA, New Delhi.

- 1) Amount demanded to be deposited in ADhoc CAMPA, Corporation Bank, Lodhi Road, New Delhi through e-challan only.

Note : As per the GOI, MoEF & CC, New Delhi F. No. 5-3/2007-FC, dated : 05-02-2009 guidelines "in case the forest area proposed for diversion is falling in protected areas, then NPV is to be collected ten times in case of National Parks and five times in the case of sanctuaries respectively of the NPV payable for such areas". Therefore the NPV value for 4.43 ha @ 8.030 per ha is Rs. 35.573 lakhs and the five times of NPV is Rs. 35.573 x 5 – Rs. 177.865 lakhs.
