(i)	Short narrative of the proposal and project/scheme for which the forest land is required.	<p>The Telangana state Panchayath Raj Engineering department is engaged in construction of rural infrastructure including roads which connects villages and tribal habitations and decided to undertake the Laying of BT road from MRL02-Mallapoor to Challagarga via Lolam, Govindpally, BeliaThanda, Dhammannapet of Indalwai(m),Nizamabad District.</p> <p>The work is sanctioned vide GO.Rt No.255 Dt:23.06.2020 of PR&amp;RD Dept. Government of Telangana, Under PMGSY-III Batch-I Grant with an Est Cost Rs:529.28 lakhs</p> <p>The total length of the road is 10.30 km starting from Mallapoor R&amp;B road to Govindpally and from Govindpally to Belia thanda, and from Dhamnnapet to Challegarga The reach from 2/075 to 4/250 km(Lolam to Govindpally) and from 9/893 to 12/233km(Dhamannapet to Challagariga) falls under forest jurisdiction. The existing width of the road is very narrow and required to be widen with the average width of 10.00m to meet BT standards,</p> <p>The stretch of length 4.51 km is passes through plain area of Lolam to Govindpally road ( 2/075 to 4/250km )and from Dhamnnapet to Challegarga(9/893 to 12/233km ) through kesaram Reserved Forest of Nizamabad Forest division. A total length of 4.51km to a average width of 10.00m is required to an extent of <b>4.5151 Ha</b> for which permission is required under FCA</p>

(iv)	Justification for locating the project in forest area	<p>This is the fastest source of connectivity for easy Commuting of private and commercial vehicles for public and Goods transport of Tribal and other habitations of Lolam , Mallapoor, Govendpally, Belia thanda, Dhammannapet thanda, Dhammannapet, Challagariga and also nearby villages to reach the Dharpally and Indalwai mandal headquarters of Nizamabad District.The population served by this road is around 5354 connecting 6 No. Habitations through out its reach. The Existing required forest reach reach falls under plain area, where no trees need to felled with in the required width of the road through out the alignment.</p> <p>Hence, the permission is sought for working in these stretch of 4.51km along reaches ( 2/075 to 4/250km ) &amp; (9/893 to 12/233km ) .</p>
