- 2. The copies of the Forest Clearance should also be submitted to the Head of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days from the date of receipt of this reference.

Further the Superintending Engineer, I & CADD, DR. BRAPP Construction Circle, Bellampally is requested to furnish the **copies of Paper clippings about the publishing of forest Clearance etc.**, as instructed by the Prl. Chief Conservator of Forests TS Hyderabad vide reference 4th cited above.

Therefore, it is requested to refer all the references in connection with this case at utmost care and furnish the required information / condition wise compliance report as called in this case urgently for taking further course of action.

This should be attended top priority.
