#### Brief note on the project

The Plantation Corporation of Kerala Limited, the largest Plantation Company in Public Sector was formed in 1962 by the Government of Kerala with an initial share capital of Rs: 750 lakhs. The purpose of establishment was to accelerate the agroeconomic development of Kerala.

Plantation Valley Farm Resort one of the units of Plantation Corporation of Kerala Limited started with a total project cost of Rs:252,75,000/- as a part of diversification of the Company in order to cope with the challenging economic scenario and emerging competition in the industry. The Athirappilly Water Falls and its surroundings are famous for their natural beauty and attracting national and international attentions. So, the company decided to exploit the high tourism potential in Athirappilly by setting up all infrastructures and facilities for encouraging domestic and international tourism by utilizing the existing infrastructure and manpower.

Two hectors of forest land is used for the Project and the Net Present Value of the land Rs: 1160,000/- has remitted to ADHOC CAMPA in CAF Kerala on 23.12.2013 as per the direction from Office of the Divisional Forest Officer., Chalackudy vide CA4/1270-2000 dated, 15.11.2013.

The Resort was inaugurated in January 2000 and commenced commercial operations in 2005 with 12 Air Conditioned Heritage type Cottages and One Dormitory. Restaurant is also functioning for the guests. It is assumed that, about 9000 – 10000 people visited Plantation Valley during the year 2016 – 17.

By "Plantation Valley" a new tourist destination is added in the tourism map of Kerala.

#### Information regarding beneficiaries of the Project

At present 24 persons and their family members are directly depending on "Plantation Valley" for survival. The new tourist destination, "Plantation Valley" is an advantage for Kerala Tourism. The infrastructural developments made by the Corporation also has helped the local public to improve their standard of living. Today, the existence of "Plantation Valley" is inevitable for the agroeconomic growth of The Plantation Corporation of Kerala.
