In continuation to this office reference 7<sup>th</sup> cited and as per the instructions issued in the reference 8<sup>th</sup> cited, the revised demand notice issued in Segment – 23/3 (Kotapally) for construction of reinforced cement concrete pillars of Chennur Division.

The Superintending Engineer, Telangana Drinking Water Supply Project,Rural Water Supply Circle, Mancherial is informed that, wherein the Government of India vide ref 1st cited has accorded in-principle (Stage-I) approval for diversion of **3.416 Ha** (3.386 Ha+0.030 Ha) of Forest Land under Forest (Conservation) Act,1980 in Chennur Division for laying of pipeline and construction of structures in **Segment 23/3 (Kotapally)** for providing safe drinking water supply in Mancherial District under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal.

Further, the Govt. of India, MoEF&CC, Chennai has issued guide lines vide F.No.4-APB648/2009-BAN/1919, Dt:28.11.2017 and communicated vide Principal Chief Conservator of Forests, TS, Hyderabad vide Rc.No.6753/2014/FCA-3, Dt:12.12.2017 that, the user agency has to deposit all kind of levies towards NPV, CA etc., in respective state CAMPA account only through e-payment method by generating challan from the Ministry's web portal and charges towards cost of trees / tree felling / demarcation charges etc., to be deposited into the Forest Divisional Officer account. - Publish the entire forest clearance granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purpose.
- The copies of the Forest Clearance should also be submitted to the Head of local bodies, Panchayaths and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days from the date of receipt of this reference.

Further the Superintending Engineer, TDWSP (RWS&S) Circle Mancherial is requested to furnish the copies of Paper clippings about the publishing of forest Clearance etc., as instructed by the Prl. Chief Conservator of Forests TS Hyderabad.

Therefore it is requested to refer all the references in connection with this case at utmost care and furnish the required information as called in this case urgently for taking further course of action.

This should be attended on top priority.
