

DEMAND NOTICE

Sir,

Sub: TSFD - F(C) Act 1980 - Diversion of 6.926 Ha of Forest land in Wildlife Management, Kinnerasani - For laying of Pipeline and Construction of structures in Segment - 25/7 (Banjara) for providing safe drinking water under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS & S) Circle Khammam - Demand Notice submitted for approval - Regarding.

It is submitted that, the Government of India vide reference 1<sup>st</sup> cited has accorded Stage - I approval for diversion of 6.926 Ha. of Forest land in favour of Superintending Engineer, TDWSP (RWS & S) Circle Khammam for laying of pipe line and Construction of structures in segment 25/7 (Banjara) for providing safe drinking water to Pinapaka Constituency under Telangana Drinking Water Supply Project, subject to fulfilment of certain conditions stipulated therein.

Further, the PCCE, TS Hyd vide reference 2<sup>nd</sup> cited has issued instructions to raise the demand note as per the actual rates and submit the demand note to the nodal officer through e-mail for vetting. Further, it is instructed that, only after vetting of the demand note by Nodal Officer, The Forest Divisional Officer should raise demand with the User Agency, who in turn has to upload the demand online on Ministry's Portal, generate challan & transfer fund through online only into the specified Ad-hoc CAMPA account of Telangana

In compliance of the above instructions, a draft demand notice is prepared and submitted for favour of kind perusal and approval. The Total Demand has been arrived to an amount of Rs. 5,00,01,180/- for this project. The User Agency has to deposit the said amount in two different accounts i.e., Telangana State Compensatory Afforestation Fund Account (Rs. 3,79,14,290/-) and Forest Divisional Officer, Wildlife Management, Kinnerasani (PD) Account (Rs. 94,86,890/-) as detailed below.

Further, it is submitted that, the proposed project is passing through the Reserve Forest Banjara to a length of 87921.989 meters and in an extent of 6.926 Ha. Therefore, 5070 Nos. of concrete pillars of 4 feet height are required @ 20 meters interval with an amount of Rs. 35,49,000/ (5070 Nos. X Rs. 700 Per No.) and 176 Nos. broad base pillars of 4 feet height @ interval of 500 meters / at the entry or exit of the RF to an amount of Rs. 17,60,000 are required as per condition no.(ii) of GoI and submitted for favour of kind information and approval.

In compliance of the above instructions, a draft demand notice is prepared and the details are as follows.

The User Agency has to deposit the above payment through e-portal method only by generating challan at Ministry's web portal i.e., forestclearance.nic.in. To generate the challan, the User Agency has to enter the details of demand notice raised in Ministry's web portal, which has to be vetted by the Nodal Officer, FCA, Telangana State. The Challan has to be generated by User Agency, depositing into Savings Bank Accounts maintained in either of the Banks mentioned below.

Further it is submitted that there is no translocation of trees proposed as most of species are hardwood species and more than 90 CMs girth and it is difficult to establish. The soil is very loose and sandy and also very deep and hence the translocated trees will not establish.
