



In continuation to this office reference 1st cited, the PCCF, Hyderabad has communicated the Stage-I approval accorded by the MoEF & CC, Gol Regional Office, Chennai has accorded in -principle Stage-I approval for diversion of 12.23 Ha (Mahabubnagar – 0.571 ha) for laying of pipeline and construction of structures for **Segment -7** – under Telangana Drinking Water Supply Project – in favour of Superintending Engineer, TDWSP Circle, Hyderabad.

✓ The User agency is requested to submit the compliance report on the following conditions:

**Condition No. II:** The demarcation of the forest area proposed for diversion shall be carried out by erecting Cement Concrete Pillars duly numbered at an interval of 20 meters at the cost of user agency. The user agency shall pay an amount of **Rs. 6,52,000.00** in favour of District Forest Officer, Mahabubnagar by D.D. towards construction of Boundary Pillars. A) Big RCC Pillars of 1.2 m base of 4' high = 26 Pillars X 8,000/- per pillar = Rs. 2,08,000/-, b) Small intermediate pre-fabricated RCC Pillars of 6"x6" of 4' high = 370 Pillars @ Rs.1200 per Pillar = Rs. 4,44,000/-.

**Condition No. V:** Identified CA land and approved CA Scheme shall not be changed without the prior approved by the central government.

(P.T.O.)

Condition No. XIV: The Forest Land proposed for diversion shall under no circumstances be transferred or subleased to any other agency, department or person without prior approval of the Central Government.

Condition No. XV: The layout plan of the proposal shall not be changed without the prior approval of the Central Government.

Condition No. XVI: The User agency shall use existing paths and roads for laying of pipeline and no new paths / roads are to be formed.

Condition No. XVII: Wherever necessary, User agency shall provide free supply of water for forest nurseries and field staff quarters and range offices, besides providing outlets with small troughs during summer for wild animals in forest areas.

Condition No. XIX: Minimal disturbance should be ensured by creating labour camps outside the forest area as far as possible and it will be the responsibility of the UA to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna.

Condition No. XX: The total forest area utilized for the project shall not exceed 12.23 Ha (Mahabubnagar - 0.571 ha) and the forest area diverted shall not be used for any purpose other than shown in the diversion proposal.

Condition No. XXI: User agency and the state government shall ensure compliance to provisions of all Acts, Rules, Regulations and Guidelines for the time being in force as applicable to the project.

Hence the User Agency is further requested to submit compliance report on the above mentioned conditions stipulated by Central government along with all necessary enclosures in six sets in original so as to submit the compliance report to the Central Government for according the Stage-II approval. Until final approval is received the user agency should not take up any activity in the area proposed for diversion as it attracts the provisions of the Forest Conservation Act, 1980. Transfer of Forest Land to user agency shall not be affected prior to issue of final approval. This in principal approval shall be valid for a period of 5 years. In event of non-compliance of the above conditions, this in principal approval shall automatically stand revoked after 5 years.

**Condition No. VIII:** The state government shall charge the Net Present Value of the forest land measuring 12.23 ha from User agency as per the orders of the Hon'ble supreme court, dated: 28.03.2008 and 09.05.2008 in I.A. Nos. 826 & 566 with related IS's in Writ petition (Civil) No. 202/1995. As per the classification of the forest the rate of NPV is fixed as **Rs. 6,26,000.00** per Ha. Accordingly the user agency shall pay **Rs. 3,57,446.00** for diversion of 0.571 Ha Forest Land.

The Superintending Engineer, RWS&S, TDWSP Circle, Mahabubnagar is requested to upload the above demand notice on the Ministries portal for vetting of Nodal Officer i.e., APCCF (FCA). After vetting and acceptance of the demand, the District Forest Officer, Mahabubnagar can be raised the demand with the user agency and see that the payment can be done in e-portal method only. The mode for remittance of Compensatory levies shall be through **e-payment portal of Ministry of Environment, Forest & Climate change only**. The User Agency has to generate challan upon acceptance of demand raised & transfer funds through online only into any of the following Ad-hoc CAMPA accounts of Telangana state. The cost of NPV (**Rs. 3,57,446.00**) (Total **Rs. 3,57,446.00**) towards Telangana Compensatory Fund (CAF) / Telangana State Compensatory Fund Management and Planning Authority (CAMPA) directly through RTGS/NEFT mode only in SB A/c. No. **037100101029963** of Corporation Bank, CGO complex, Lodhi Road, New Delhi – 110 003 (RTGS/IFSC No. CORP0000371) or in SB A/c. No. **344902010106351** of Union Bank of India, Sundar Nagar, New Delhi – 110003 (RTGS/IFSC No. UBINO534498) and report compliance. **Condition No. IX:** Additional amount of Net Present Value (NPV) of the diverted forest land, if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, Shall be charged by the State Government from User Agency.

**Condition No. XI:** Trees standing in the diverted area shall be felled strictly as per requirement with prior permission of the District Forest Officer concerned.


**Condition No. XII:** The Muck Generated in earth cutting if any will be disposed off at designated dumping sites and in no case the muck/debris will be disposed off in the forest areas.

**Condition No. XIII:** The State Forest Department shall translocate the trees, wherever feasible instead of felling, at the cost of user agency.


