

Sub: Diversion of 7.305 Ha of forest land for laying of 400 KV Quad Moose Doble Circuit Line from Jammalamadugu to Narnoor (Kurnool) passing through Giddalur CA block and Bethamcherla RF of Kurnool Forest Division in favour of Executive Engineer, 400 KV Construction Division, AP TRANSCO, Kadapa - - Compliance report on the conditions stipulated while according stage - I approval - Raising of demand for payment of revised CA, NPV & Dwarf species scheme amount - Reg.

It is informed that the GOI has accorded approval in Principal (Stage-I) vide reference cited for diversion of 7.305Ha of forest land in Giddalur CA block and Bethamcherla RF of Kurnool Forest Division for laying of 400 KV Quad Moose Doble Circuit Line from Jammalamadugu to Narnoor (Kurnool) in favour of Executive Engineer, 400 KV Construction Division, AP TRANSCO, Kadapa subject to the following **12** conditions.

1) The legal status of the forest land shall remain unchanged.

The legal status of the forest land shall remain unchanged.

2) The demarcation of the proposed forest area shall be carried out by erecting 4 ft height cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency before stage-II approval.

The user agency has to demarcate the forest area proposed for diversion in Giddalur CA block and Bethamcherla RF of Kurnool Forest Division on ground with 4 ft height Cement concrete pillars of size 0.45x0.45x1.5 Mt at 20 Mt. apart and bottom 0.3 Mt. inside the ground level and 1.2M. above ground level.

3) Cost of raising Compensatory Afforestation (CA) shall be raised and maintained by the State Forest Department over 14.65 Ha of identified degraded forest land in compt.no.54 in Adoni Range at the cost of user agency.

The user agency is requested to pay of Rs. 109.86 Lakhs (One crore nine lakhs and eighty six thousand only) towards in favour of in SB Account No.SB01025198-CAF Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003 (RTGS/IFSC No.CORP0000371) or in SB A/c No.344902010105 407- ANDHRA PRADESH CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBIN0534498).

- 4) **Revised CA scheme which includes cost towards raising plantation and maintenance for 7 to 10 years, fencing, watch & ward etc shall be furnished along with the compliance report and state Government of Andhra Pradesh shall collect revised cost towards CA from the user agency.**

The user agency is requested to pay of Rs. 109.86 Lakhs (One crore nine lakhs and eighty six thousand only) towards revised CA scheme in favour of in SB Account No.SB01025198-CAF Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003 (RTGS/IFSC No.CORP0000371) or in SB A/c No.344902010105 407- ANDHRA PRADESH CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBIN0534498).

- 5) **Cost of raising plantation of Dwarf species preferably medicinal plants in the right of way under the Transmission line shall be realized from the user agency.**

The user agency shall pay Cost of Dwarf species preferably medicinal plants over 7.305 Ha of diverted area under the transmission line as per the demand raised by Forest Department. The demand will be raised within 10 days.

- 6) **The State Government shall charge the Net Present Value of the diverted forest land measuring 7.305Ha from user agency as per orders of the Hon'ble Supreme court dated 28.03.2008 and 09.05.2008 in IA No.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995.**

The NPV has been calculated as per the guidelines issued by the ministry of Environment & Forest vide Lr.No:5-3/2007-FC, Dt: 05.02.2009 Communicated in Prl. Chief Conservator of Forests, A.P, Hyderabad Rc.No:45621/01-F4, Dt: 26.02.2009 and Conservator of Forests, Kurnool Rc.No:1585/2009-TO, Dt: 12.03.2009. As per the field inspections notes dt:10.03.2015. The density of the forest area proposed for this project is open forest and it comes under ECO-Class- III and the NPV for 7.305 Ha is worked out of Rs.45.73 Lakhs @Rs.6.26 Per 1 Ha. The user agency is requested to pay Rs.45.73 Lakhs towards the NPV.

- 7) **Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of india in future, shall be charged by the State Government from user agency. User Agency shall furnish an undertaking to this effect.**

The user agency is requested to furnish the undertaking in 8 sets as indicated below.

UNDERTAKING

"I hereby undertake to pay additional amount of the Net Present Value (NPV) of the diverted forest land, if any becoming due after finalization of the same by the Hon'ble Supreme court of India on receipt from the expert committee which shall be charged by the Government."

- 8) **The funds received from the user agency towards Compensatory Afforestation, and Net Present Value under this project shall be deposited either in SB A/c. No:SB01025198- CAF Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi -110003 (RTGS/IFSC No.CORP0000371) or in SB A/c No.344902010105 407 - ANDHRA PRADESH CAMPA, Union Bank of India, Sundhar Nagar, New Delhi-110003 (RTGS/IFSC No.UBIN0534498). The details of deposition of funds *inter - alia* the DD Numbers & date, Amount, the Bank on which drawn and the date of deposition in the designated Bank shall also be furnished.**

The user agency is requested to pay of Rs.109.860 Lakhs (One crore nine lakhs and eighty six thousand only) towards revised CA and Rs.37.80 lakhs (thirty seven lakhs and eighty thousand only) towards Dwarf species of Medicinal plants scheme and Rs.45.73 lakhs (forty five lakhs and seventy three thousand only) towards NPV in favour of SB A/c. No:SB01025198- CAF Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi -110003 (RTGS/IFSC No.CORP0000371) or in SB A/c No.344902010105 407 - ANDHRA PRADESH CAMPA, Union Bank of India, Sundhar Nagar, New Delhi-110003 (RTGS/IFSC No.UBIN0534498). The details of deposition of funds *inter-alia* the DD Numbers & date, Amount, the Bank on which drawn and the date of deposition in the designated Bank shall also be furnished.

- 9) **User agency shall bear the cost every year for special protection of the forest blocks through which the line is passing, as per the assessment of Divisional Forest Officer, Kurnool. User Agency shall furnish an under taking to this effect.**

The user agency is requested to furnish the undertaking in 8 sets as indicated below.

UNDERTAKING

"I hereby undertake the cost every year for special protection of the forest blocks through which the line is passing, as per the assessment of Divisional Forest Officer, Kurnool".

- 10) **The user agency and the State Government shall ensure compliance to Ministry's guidelines F.No.7-25/2012-FCdated 5th May, 2014 and provisions of the all Acts, Rules, Regulation and Guidelines of the Ministry, for the time being in force, as applicable to the transmission line projects.**

The user agency is requested to furnish the undertaking in 8 sets as indicated below.

UNDERTAKING

"I hereby undertake the State Government shall ensure compliance to Ministry's guidelines F.No.7-25/2012-FCdated 5th May, 2014 and provisions of the all Acts, Rules, Regulation and Guidelines of the Ministry, for the time being in force, as applicable to the transmission line projects".

- 11) The forest land shall not be used for any purpose other than the specified in the proposal and the total forest area utilized for the project shall not exceed 7.305 ha and the width of right of way shall not exceed 46 Mtr. User agency shall furnish an under taking to this effect.

The user agency is requested to furnish the undertaking in 8 sets as indicated below.

UNDERTAKING

"I hereby undertake the forest land shall not be used for any purpose other than the specified in the proposal and the total forest area utilized for the project shall not exceed 7.305 ha and the width of right of way shall not exceed 46 Mtr".

- 12) Any other condition that the Additional Prl.Chief Conservator of Forests (Central) Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied by the user agency.


As per the conditions specified in the GOI Lr.No.11-9/98-FC, Dt:03.01.2005 will be strictly implemented.
