In compliance of the ministry of environment and Forests (MoEF), Government of India's letter No.11-9/98-FC(pt) dated:03-08-2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated:5th February – 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that, 0.9717 Ha Forest land proposed to be diverted for construction of approach road to reach the agricultural and farm lands from Srisailem Highway to Lemoor village in favour of Tumfor Agrifarms LLP, Shaikpet Nala, Hyd under Forest conservation Act. 1980.






District Forest Officer, RR Dist., has submitted a report stating that RoFR certificate for diversion of Forest land for an extent of 0.567 Ha was already been issued. Now as per the additional information called for by the Integrated Regional Office, MoEF&CC Govt. of India, Hyd, the Addl. Prl. Chief Conservator of Forests, Rangareddy has suggested the alternative road all along the periphery of Tumaloor Block. Accordingly the revised area to be diverted is estimated as 0.9717 Ha and a revised RoFR certificate for diversion of 0.9717 Ha of forest land in Tumloor RF of Shamshabad Division for construction of approach road to reach the agricultural and farm lands from Srisaillam Highway to Lemoor village in favour of Tumfor Agrifarms LLP, Shaikpet Nala, Hyd is required. Hence it is requested to issue revised RoFR certificate in the prescribed Form-I for further processing of diversion proposals.

Accordingly, the Sarpanch Thummaloore of Maheshwaram Mandal and the Sarpanch Lemoor of Kandukur Mandal have issued No Objection by unanimously passing resolution stating that there is no objection for diversion 0.9717 Ha of forest land.

Basing on the resolution passed by the Gram Panchayath Thummaloore and Lemoor in Grama Sabhas, the members of Sub-Divisional Level Committee have no objection regarding the diversion of Forest land admeasuring 0.9717 Ha of forest land in favour of Tumfor Agrifarms LLP, ShaikPet NALA, Hyderabad and subsequent issue of certificate in Form-I.
