JUSTIFICATION NOTE FOR THE PROPOSAL

Corporate Social Responsibility is a term where a company's efforts to improve society in nonprofits to implementing environmentally friendly Living nature/policies to public / workplace. Based on the CSR Project driven by M/s. SICAME India Connectors Ltd with the objectives of Rural electrification to the nearby villages in a eco-friendly manner.

Based on the above, it is proposed to erect the 11KV Aerial Bunch Cable over Poles instead of erecting Over head lines in the Sirungundram village in chengalpattu district.
