In compliance of the Ministry of Environment and Forests (MOEF) Government of India's letter No.12-/2018-19-FC (pt) dated 18th January 2019 wherein the MOEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Schedule Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ("FRA" for short) on the forest land proposed to be diverted read with MOEF's letter No.FEE 170 FLL 2012 dated: 26.11.2013 wherein MOEF issued certain relaxation in respect of linear projects, it is certified that **02.40 hectares** of forest land proposed to be diverted in favour of **MSPL Limited (M.L.No:2563)** (Name of user agency) for connected road to mining lease area purpose (purpose for diversion of Forest land) in **Bellary District** fall **Jaisinghpura Village Susheela Nagar Gram panchayat in Sandur Tahsils.**

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **02.40 hectares** of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee, Grama (Ward) Sabha, Sub-Division Level Committee and the District Level Committee are enclose as Annexure 01 to 03.
- b) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabha have given their consent to it.
- c) The proposal does not involve recognized rights of primitive Tribal Groups and Pre agricultural Communities.
- d) For the entire **02.40 hectare** of Forest area proposed for diversion there are no settlement and forest dwellers and no rights / claim are pending.

In compliance of the Ministry of Environment and Forests [MOEF], Government of India's Letter No.11-9/98-FC (pt) dated 3rd August 2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes it is certified that 30.09 Hectares of forest land proposed to be diverted in favour of **MSPL Limited (M.L.No: 2563)** (name of user agency) for mining purpose (purpose for diversion of Forest Land) in Bellary district fall within jurisdiction of **Jaisinghpura Village Susheela Nagar Panchayath in Sandur tahsils**,

It is further certified that:

- c) The concerned Grama Sabha, has certified that all formalities / processes under the FRA have been carried out, and that they have given their consent to proposed diversion and the compensation and ameliorative measures, if any having understood the purpose and details of proposed diversion. A copy of Certificate issued by Grama Sabha is here by attached is enclosed as annexure 01.
- d) The discussions and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Grama Sabha present;
- e) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Grama Sabhas have given their consent to it;

f) As there are no such Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguard as per section 3(1) (e).
