It is to inform that, as per the Condition no.III of Stage-I approval as stipulated by the GoI, the user agency in consultation with the State Forest Department shall undertake planting of 10 times of the trees proposed to be felled in degraded forest land at the project cost. In this regard, the user agency agreed to comply with the condition and to take up plantation as per the Condition no.III of Stage-I approval as stipulated by the GoI. The user agency has given undertaking for implementation of the condition.

In this connection, the Forest Range Officer, Kakinada has submitted Action Plan for raising of Eucalyptus Clonal plantation over 2.20ha for an amount of Rs.3.501 lakhs for raising 10 times of the trees felled (353 nos x 10 times = 3530 trees) and the same has been submitted to the Conservator of Forests, Rajahmundry Circle, Rajamahendravaram through the reference 15<sup>th</sup> cited.

Hence, it is requested to pay an amount of Rs.3.501 lakhs to the CAMPA account through challan generated in the Ministry's Web Portal at an earliest and report compliance.
