TO WHOM SO EVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forest (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 00-40-50 hectare of the forest land proposed to be diverted in favour of Nodal Officer, HPCTBSM&DA, Rampur for construction of Bus Stand, at Luhari in Kullu district falls within jurisdiction of Gram Panchayat, Behna village in Anni Tehsil.

It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 00-40-50 hectare of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub Division Level Committee(s) and District Level Committee are enclosed as annexure A to annexure D.
- (b) The proposals for such diversion (with full details of the project and its implications, in vernacular/ local language) have been placed before each concerned Gram Sabha of forest dwellers, who are eligible under the FRA.
- (c) The each of concerned Gram Sabha(s) has certified that all formalities/ processes under the FRA have been carried out and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any having understood the purpose and detail of proposed diversion. A copy of certificate issued by the Gram Sabha of Behna villages (s) is enclosed as annexure C to annexure D.
- (d) The discussion and decision on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present.
- (e) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it;
- (f) The right of Primitive Tribal Groups and Pre-Agriculture Communities, where applicable have been specifically safeguarded as per section 3(1)(e) of the FRA.
