Sub: Submission of forest proposal for diversion of forest land for Widening/Upgradation of Intermediate lane to 2-Lane with paved shoulders configuration of Nashik – Peth Section Km 11/600 – Km 65/600 of National Highway No. 848 in Nashik District in the State of Maharashtra.

In the reference of above mentioned subject & reference no.1, We had submitted the Forest clearance proposal online on 8 August 2016 for diversion of 4.31 Ha land of forest. After Site inspection/verification by Dy. Conservator of Forest (West) Nashik Forest Division officials, total forest area assessed to be diverted was 8.225 ha. We had submitted the updated Forest clearance proposal accordingly on 26.09.2017. After approval of Nodal office, we had submitted the hard copy of the same proposal to concern DC/DFO and uploaded the receiving's on web portal of forest clearance for further process.

In the meanwhile, after instruction of Competent authority/ Deputy Collector, Land Acquisition Nashik the area was reverified with Deputy Superintendent land record and West Nashik Forest Department and as per reference of reverified forest area verification report, updated final forest area is 7.332 ha instead of previous 8.225 ha. Hence Dy. Conservator of Forest (West), Nashik Office requested to submit the updated Forest clearance proposal as per reverified forest area with reference No.2. So this Office submitted the hard copy of the updated proposal & request for providing the access to the Web portal of Forest Clearance for uploading the updated proposal with reference letter No.3 to Dy. Conservator of Forest (West), Nashik

We are herewith submitting the updated documents as per verified forest area (7.332 ha) along with site inspection report received from D.C.F. (West) Nashik Forest Division for further action from your end at the earliest.
