

It is submitted that, in the reference 1<sup>st</sup> cited the Government Of Andhra Pradesh has issued Stage-I approval for diversion of 0.040 ha of Forest land in Compt.no.564 of Seethakonda Forest Block for laying of approach road to existing Burial ground of Visakhapatnam Range & Division in favour of Executive Engineer, Greater Visakhapatnam Municipal Corporation, Visakhapatnam with certain conditions. The same was communicated by the Prl.Chief Conservator of Forests A.P. Hyderabad in the reference 2<sup>nd</sup> cited (copies of the references enclosed) for subrnission of compliance report point wise as per the Stage-I approval by the Government.

Hence the Executive Engineer, Greater Visakhapatnam Municipal Corporation, Visakhapatnam is requested to go through the conditions stipulated i to viii in the G.O.Rt.no.126 EFS&T (Section.II) Dept., dt:21-06-2017as per reference 1<sup>st</sup> cited and also follow the instructions issued by the Prl.Chief Conservator of Forests A.P. Hyderabad with out any deviation and publish the entire forest clearances granted in verbatim along with the conditions in Telugu and English to make people awareness and also be submitted the copies to the Heads of local Bodies, Panchayats and

Municipal Bodies by the project proponents of the G.O. copy to other relevant offices of the Government who intun has to display the same in 30 days.

The user agency should pay the Net Present Value (NPV) Rs.0.18 lakh for the diverted forest land shall be deposited in CAMPA account either in SB A/c no. SB 01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh, Corporation Bank, Lodhi Complex Branch, Ground Floor, Block no.11, CGO Complex Phase-I Lodi Road, New Delhi – 110003 as per the CAMPA, New Delhi Lr.no.12-2/2010-CAMPA, dated:20-02-2017 through online RTGS and submit the receipts along with the compliance report to the conditions stipulated in the references cited point wise for onward submission to the Prl.Chief Conservator of Forests A.P. Guntur for further action in the matter.
