DEMAND NOTICE

Sub : APFD-F.C Act ,1980 – Diversion of 0.9916 Ha of forest land in Nellore Division for Up-gradation of NH-565 from Km.425/400 to 509/400 i.e. from Penchalakona to Yerpedu Section to two lane with paved shoulders in the State of Andhra Pradesh under NHDP-IV, in favour of Ministry of Road Transport and Highways, Government of India –in Principle (Stage-1) approval accorded –Demand notice for payment of Net Present Value – issued –Request for conditions compliance –Reg.

In the reference 1st cited, the State Government has accorded in-principle (Stage-I) approval for diversion of forest land U/s 2 of Forest Conservation Act, 1980 over an extent of 0.9916 Ha of forest land in Nellore Division for Up-gradation of NH-565 from Km.425/400 to 509/400 i.e. from Penchalakona to Yerpedu Section to two lane with paved shoulders in the State of Andhra Pradesh under NHDP-IV, in favour of Ministry of Road Transport and Highways, Government of India subject to certain stipulated conditions.

In the reference 2nd cited, the Prl. Chief Conservator of Forests (HoFF), A.P, Hyderabad had communicated the State Government approval in-principle (Stage-I) and instructed to raise Demand Notice to the User Agency for payment of Net Present Value (NPV) amount. The Prl. Chief Conservator of Forests further instructed to obtain compliance as per the conditions stipulated in the reference 1st cited from the user agency.

For fulfillment of condition No.(iii) the user agency is required to deposit the following amount.

The user agency should pay the above said amount of Rs.4,34,321/- through e-payment mode i.e. challan generated through the Ministry's website portal (i.e. www.forestclearance.nic.in) and deposit the amount either in SB A/c No.SB01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh, Corporation Bank, CGO complex, Lodhi Road, New Delhi-110 003 (RTGS/IFSC No. CORP0000371) or in SB A/c No.344902010105407 - Andhra Pradesh CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS / IFSC No. UBINO534498).

The user agency is also requested to submit condition wise compliance as stipulated in the reference 1st cited. In addition to the above the user agency should comply the following in accordance with the Government of India instructions issued vide F.No.7 - 23/2012-FC,dt.24.07.2013.

1. Publish the entire forest clearances granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspapers, one in vernacular language and the other in English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purposes.
2. The copies of the Forest clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days.

Further, the user agency is requested to submit unconditional undertaking on Rs.100/- judicial stamp paper to pay the revised amount of Net Present Value of the diverted forest area if any becoming due after revision of the same by the Supreme Court of India in future. The User Agency should note that transfer of forest land should be effected only after according of final approval.

The receipt of the demand notice may please be acknowledged on the duplicate copy enclosed and resubmit the same to this office by return of post.




