Sub:- To authorize Nodal Officer for submission of Catchment Area Treatment (CAT) Plan-reg.

Ref:- 1) Consolidated Guidelines and Clarifications issued Central Government under Van (Sanrakshan Evam Samvardhan) Adhiniyam , 1980 on 29/12/2023
2) The Government of India, MoEF&CC, New Delhi letter dated 24/02/2025

The Central Government in Para 9.2 in the Consolidated Guidelines and Clarifications issued under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 has given following directions in respect of Catchment Area Treatment (CAT) Plans:-

9.2 Catchment Area Treatment (CAT) Plans:- A proposal for diversion of forest land for Irrigation/Hydro-electric projects shall invariably be accompanied by detailed CAT plan except in respect of small hydel projects (maximum up to 10 MW capacity), which are either canal head or run-of the river projects and do not involve impounding of water/submergence of forest land.

2.0 Now, the Government of India, MoEF&CC, New Delhi vide reference No.2 has informed the copy of the Catchment Area Treatment (CAT) Plan should be submitted as approved by the Principal CCF & HoFF or any other officer authorized by him as per Para 9.2 (vii) of consolidated Guidelines and Clarifications issued under Van (Sanrakshan Evam Samvardhan), Adhiniyam, 1980.

3.0 The Para 9.2 (vii) of Consolidated Guidelines and Clarifications issued under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is reproduced as below:-

'CAT plan shall be approved by the Principal CCF & HoFF or any other officer authorized by him for the purpose'

4.0 In the light of the background mentioned above and in accordance with the communication from the Central Government as per reference No.2, the undersigned hereby authorized the Additional Principal Chief Conservator of Forests & Nodal Officer for submission of the Catchment Area Treatment (CAT) Plans to State Government/Central Government for seeking approval under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980
