Respected Sir,

The Government of Gujarat has planned for establishment of various sub-station under 12th five year plan. For this GETCO has planned to established 66KV sub-station at village :-Morzira Ta-Dang, District-Dang under TASP Scheme and also planned accordingly erection of 66KV D/C tower line from exist 66KV Subir substation to Proposed 66KV Morzira substation for uninterrupted power supply and good quality power with better voltage regulation in surrounding area and further development of this tribal area.

This office had submitted proposal to forest department vide letter at reference no.1; for the Diversion of 14.4511 Hac. Forest land for forest clearance for Erection of 66KV D/C tower line from exist 66KV Subir substation to Proposed 66KV Morzira substation. The **procedure for forest approval requires certificate from collector of Dang regarding Schedule Tribe & other traditional forest dwellers (recognition of forest rights) Act – 2006**. This all procedure was carried out and your good self-office had given FRA Certificate to this office vide reference -3. But during detail verification of forest land found minor variation in forest area. The route is same but forest land area minor raised. Hence, new FRA Certificate is required on base of old FRA certificate with **14.7031 Hac area**.

So you are kindly requested to give the Revised FRA certificate. Further to inform you that on receipt of this certificate from collector of Dang the proposal will be submitted from Forest Department Gandhinagar to Government of India for final approval.

Hence, it is kindly requested to issue the above mentioned certificate.
