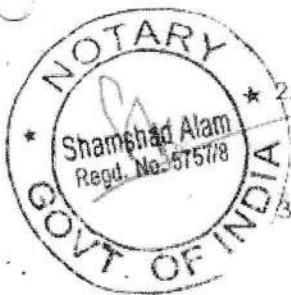

4. To apply for and appear before various authorities with regard to change of land use and file and execute all connected documents/deeds/papers in regard to the same.
