- 17. Dates and duration of your field visits to the proposed site: Visited on 24.11.2015 along with the departmental staff and Mr. A. K. Hom, Addl. General Manager (S), representing NTPC Ltd, from 1.00 PM to 5.00 PM. The same team again visited on 30.12.2015 from 11.00 AM to 3.00 PM
- 18. Do you agree that the present proposal of diversion of NP/WLS area is the best or the only option and is viable: The present proposal of project does not fall within the Chakrashila Wildlife Sanctuary.
- 19. Any other information that you would like to bring to the notice of the state Board for Wildlife, National Board for wildlife or its standing Committee that may be relevant and assist in decision making: The Draft Proposal of Chakrashila Eco-Sensitive Zone has already been

submitted with proposal of 3.00 KM radius all around the PA. The present project location area i.e. Main Plant with Offsite area & township and Ash Dyke site lie 7.00 KM away from the northern boundary of the PA i.e Chakrashila Wildlife Sanctuary. However, the notification of declaring Chakrashila Eco-Sensitive Zone is not yet come out from the Government.

20. Do you recommend the project? (Please provide full justification to support your recommendations: Yes. The ongoing/under construction NTPC Bg TPP project is meant for production of electricity power to meet the power hungry state and development of districts in lower Assam. The proposed project also does not fall within PA i.e. Chakrashila Wildlife Sanctuary. Although, the area of Chakrashila Eco-sensitive Zone is supposed to be 10.00 KM around the PA, but due to practical difficulties, situation and demand of various NGOs, local public, Organizations etc. it has been proposed to be 3.00 KM radius around the Chakrashila Wildlife Sanctuary. There PA is mainly dedicated to Golden Langur (Trachypithecus geei), a Schedule-I animal under Wildlife (Protection) Act, 1972 and as amended time o time. However, other important flora and fauna also exist in the PA. There is no wild elephant population in Chakrashila Wildlife Sanctuary as well as in the near RF/PRFs like Nadangiri Hill RF, Buxamara RF, Phukagaon RF, Satbhendi RF, Amguri PRF Pt-I & II, Nayekgaon PRF Pt-I & II etc. The Area also not an elephant corridor.

The project is also expected to provide the following direct and indirect benefits-

- (i) Source of direct and indirect employment to the local people through Agency Contractors working for NTPC as skilled labours, semi-skilled labours, operators etc.
- (ii) NTPC would also employ the local people for various jobs from which other people will also get economic benefits.
- (iii) The project also expected to provide educational opportunities-like technical skills like ITI through Academic Industry-interfacing. It will also be a source of educational opportunities to the schools/colleges/students to enhance their knowledge level regarding various activities of power plant, industrial management etc.
- (iv) Besides above, other social welfare activities like maintenance activities in plant to provide necessary livelihood, women empowerment, skill development in different areas of livelihood activities, activities through NGOs, organizing medical camps for treatment, awareness campaign, promoting sports activities, scholarships and other material helps to local educational institutions etc.

However, the project in-spite of taking all environmental precautions to check/control/minimize pollution, the pollution to certain extent cannot be ruled out in total. Hence the project is recommended for approval for enabling the NTPC Bg TPP Ltd. To execute is complete subject to the following conditions of mitigation measures to be taken and all the financial expenditures/costs would be born or responsibility taken by NTPC Bg TPP Ltd., Salakati as per Plan & Estimates to be submitted as and when required after approval of the State Board of Wildlife (SBWL) & National Board of Wildlife (NBWL)

Hence, the proposed project is recommended to be considered favourably for enabling the NTPC Bg. TPP authority to execute in reality and complete to provide the benefits already mentioned subject to fulfillment of above mitigation measures proposed.

Annexure-A

Opinion of the in-Charge of the National Parks/Wildlife Sanctuaries

The Bongaigaon Thermal Power Station(BTPS) was the biggest power plant situated at Salakati in the district of Kokrajhar, Assam for producing electrical power consisted with four coal fired units of 60 MW each. But the power producing units could not deliver the required level of generation of power in the last 20 years for which the station was shut down.

To revive the plant, the alternative was NTPC's proposal to set up a new 750 MW (3X250MW) Thermal Power Station at the same location by NTPC Ltd. The project foundation was laid down by the then Hon'ble Prime Minister of India Dr. Manmohan Sigh in December, 2006. The area of main Plant with Offsite & township is 684.00 acres (273.60 Ha.) and Ash Disposal area is 210.00 acres (84.00 Ha.)

Although, the area of Chakrashila Eco-sensitive Zone is supposed to be 10.00 KM around the PA, but due to practical difficulties, situation and demand of various NGOs, local public, Organizations etc. it has been proposed to be 3.00 KM radius around the Chakrashila Wildlife Sanctuary. The NTPC project site(s) i.e. Main Plant & Offsite area with township and Ash disposal area do not fall within PA area i.e. Chakrashila Wildlife Sanctuary. Both the sites are 7.00 KM away from the PA boundary i.e. Chakrashila Wildlife Sanctuary. There is no wild elephant population in Chakrashila Wildlife Sanctaury as well as in Reserve Forests and Proposed Reserve Forests nearby under Haltugaon Division. The area is also no an elephant corridor. The Chakrshila Wildlife Sanctuary is mainly designated to Golden Langur (*Thrachypithecus geei*) the endemic primate and Schedule-I animal found only in this area of lower Assam right from river Sankoch in the west to Manas NP in the east including Bhutan along Indo-Bhutan international border. However, other important flora and fauna also found in Chakrashila Wildlife Sanctuary.

It is expected that the NTPC's new Thermal Power Plant will be able to provide power to meet the great increase of demand not only in BTAD and lower Assam area but in the whole state of Assam. The power generated will reduce the gap of demand and supply.

The project is also expected to provide the following direct and indirect benefits-

- (v) Source of direct and indirect employment to the local people through Agency Contractors working for NTPC as skilled labours, semi-skilled labours, operators etc.
- (vi) NTPC would also employ the local people for various jobs from which other people will also get economic benefits.
- (vii) The project also expected to provide educational opportunities-like technical skills like ITI through Academic Industry-interfacing. It will also be a source of educational opportunities to the schools/colleges/students to enhance their knowledge level regarding various activities of power plant, industrial management etc.
- (viii) Besides above, other social welfare activities like maintenance activities in plant to provide necessary livelihood, women empowerment, skill development in different areas of livelihood activities, activities through NGOs, organizing medical camps for treatment, awareness campaign, promoting sports activities, scholarships and other material helps to local educational institutions etc.

However, the project in-spite of taking all environmental precautions to check/control/minimize pollution, the pollution to certain extent cannot be ruled out in total. Hence to execute the project in complete, it will be subject to the conditions of mitigation measures to be taken and the financial expenditures/costs would be born or responsibility taken by NTPC Bg. TPP Ltd., Salakati as laid down under Column 20 of PART-III which is replicated again as below.

It is expected that, the proposed project of NTPC Bg TPPP, Salakati with its Ash Disposal area will not have as such adverse impact on Chakrashila Wildlife Sanctuary and its wildlife habitat as well as the existing flora and fauna if above mitigation measures are taken up.

Hence, the proposed project is recommended to be considered favourably for enabling the NTPC Bg. TPP authority to execute in reality and complete to provide the benefits already mentioned subject to fulfillment of mitigation measures proposed under column 20 of PART-III and above.
