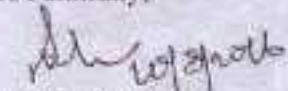
Sir,

In pursuance of the letter no. under reference of Govt. of Orissa Forest & Environment Department, this is to inform you that the cost of Wildlife Management Plan is to be paid @ Rs. 43,000/- (Rupees Forty Three Thousand) only per hectare for the mining lease area with immediate effect as calculate below:-

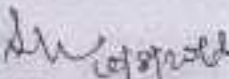

CAMPA - remittance of compensatory levies - requirement of payment
 only through the e-payment mode.

Sir,

The e-payment module for payment of compensatory levies payable in lieu of
 diversion of forest land under the Forest (Conservation) Act, 1980 was formally launched by
 the Hon'ble Union Minister of State (Independent Charge) for Environment Forest & Climate
 Change, through Video Conferencing, on the 27th August 2016. It was prescribed, in this
 Office circular of even number dated the 15th August 2015 that payment of compensatory
 levies through the e portal will be optional till 14th September 2015, from 15th September
 2015, all deposits of compensatory levies shall only be through the e-payment portal and
 such payments will not be accepted through any other mode.

2.

Subsequently:

- > Vide circular dated 23rd September 2015, it was conveyed that the payment through
 e portal will be optional till 14th October 2015, and from 15th October 2015 onwards
 all deposits of compensatory levies shall only be through the e-payment portal;
- > Keeping in view the difficulties on account of poor internet connectivity, the time
 allowed for switch over to the e portal was extended for the North Eastern States,
 and the Andaman & Nicobar Islands, till 31st March 2016 as conveyed to all
 concerned, vide circular dated 12th October 2015;
- > After consideration of the issue in the 31st meeting of the Ad-hoc CAMPA held on 6th
 January 2016, a further 3 months' time was allowed vide instructions issued under
 even number, dated the 15th February 2016.

3.

It has been observed that the response of the States/ UTs has not been
 encouraging; despite repeated extensions of time having been allowed, the number of cases
 in which payment has been made through the e-payment mode has been insignificant.

4.

After considering all relevant factors, it has been decided that no payments
 by any mode other than the e-payment should be accepted after 30th June 2016. The
 payments made other than through the e-payment module, on or after 1st July 2016 shall

not be taken into account for the grant of final clearance and/ or working permission under the provisions of the Forest (Conservation) Act 1980.

5. The above instructions shall, however, not apply to the States of Jammu & Kashmir, the North Eastern States, and to the Andaman & Nicobar Islands for whom instructions will issue separately after assessing the efficacy of e-connectivity in these States.
