2016/REV-2/Lnd-2/CR-78/Dt.04.04.2014 ereas \* the Government of Maharashtra has, in reise of the powers conferred by section 3 of the ian Forest Act, 1927 (16 of 1927), decided to stitute \* the forest-land/waste-land which is the perty of Government, or over which the Government proprietary rights, or to the whole or any part of forest-produce of which the Government is entitled, a specifically mentioned. In the Schedule appended to (hereinafter referred to as "the said land"), to reserved forest:

Now, therefore, in exercise of the powers ierred by section 4 and 17 of the Indian Forests 1927 (16 of 1927), read with the Government ification, Revenue and Forests Department, FLD.1081-F-6, dated the 21st October 1981 ted in exercise of the powers conferred by subon (4) of section 3 of the Bombay Commissioners
