
2. It is reported / observed by the Tahasildar that though the Kisam of identified land is "River", but there is no river or any other water flow in the suit land. The suit land is free from encroachment and fit for compensatory afforestation. The copy of trace map of the suit land is also enclosed herewith for ready reference.

You are therefore, requested to consider the matter and a line of confirmation on proposed CA land may please be intimated to this office for kind perusal of the Collector. Further course of action for Compensatory Afforestation in lieu of forest land being diverted for non-forest use may be taken at your end as per under the provision of Forest (Conservation) Act, 1980.
