In exercise of the power delegated to me vide Gazette Notification No. S.O. 1857(E) dated 18.05.2016, I hereby <u>Approve</u> the Mining Plan including Progressive Mine Closure Plan of Netrabandh Pahar Iron Ore Block Mine over an area of 139.223 ha of M/s Bhushan Power & Steel Ltd in Sundargarh district of Odisha State submitted under Rule 13 of Mineral Concession Rules, 2016. This approval is subject to the following conditions:

I. The Mining Plan is approved without prejudice to any other law applicable to the mine area from time to time whether made by the Central Government, State Government or any other authority and without prejudice to any order or direction from any court of competent jurisdiction.

II. The proposals shown on the plates and/or given in the document is based on the lease map /sketch submitted by the applicant/ lessee and is applicable from the date

of approval.

III. It is clarified that the approval of aforesaid Mining Plan does not in any way imply the approval of the Government in terms of any other provision of Mines & Minerals (Development & Regulation) Act, 1957, or the Mineral Concession Rules, 2016 and any other laws including Forest (Conservation) Act, 1980, Environment (Protection) Act, 1986 or the rules made there under, Mines Act, 1952 and Rule & Regulations made there under.

IV. Indian Bureau of Mines has not undertaken verification of the mining lease boundary on the ground and does not undertake any responsibility regarding correctness of the boundaries of the leasehold shown on the ground with reference

to lease map & other plans furnished by the applicant / lessee.
