To present for registration and admit execution of the document/s or deed/s and to do every act, matter or thing necessary or proper to enable registration of all deeds, instruments, contracts, agreements, receipts and all other documents whatsoever in nature on behalf of the Corporation. **Power to present for registration**
4. To institute, conduct, defend, refer to arbitration, compound, settle, abandon any legal proceedings, by or against the Corporation or its officers or otherwise concerning the affairs of the Corporation and to compound claims and disputes and allow time for payment or satisfaction of any debts, dues or of any claims or demands by or against the Corporation. **Power to institute legal Proceedings & compound claims etc.**
5. To accept service of any writ of summons or other legal processes and to appear and to represent the Corporation in any courts and before all judges, magistrates or judicial, revenue and administrative or executive officers or bodies or tribunals and before all other Statutory/Quasi-Judicial Authorities including Municipal, Industrial, Labour, Income-Tax, Excise and **Power to Appear and Accept Summons Notices etc.**

To appoint and engage for and on behalf of the Corporation an advocate, Solicitor Firms, Chartered Accountants, Tax consultants and/or representative by whatever name to appear before any Court, Tribunal, Statutory Authority, Quasi Judicial Authority or any other Authority and to sign Vakalatnama or Authority Letter in favour of such persons. **Power to appoint advocate Solicitors etc.**
10. To appear, sign, affirm and verify the petition, plaint, memo, complaint, reply by whatever name, affidavits, undertaking, give evidence documentary or oral for and on behalf of the Corporation before any Court, Tribunal, Statutory Authority, Quasi Judicial Authority or any other Authority and authorize an officer of the Corporation or **Power to sign & verify Pleadings**

To ask, demand, sue for, recover and receive of and from all and every person or persons or body politic or corporate, firm or company wheresoever and whatsoever all or any sums of money, debts, dues, chattels, goods, effects, merchandise and things of whatsoever nature or description which at any time or times hereafter shall or may become due or owing or payable to or deliverable to or recoverable by or belonging to the Corporation (either solely or jointly with others) by virtue of any security, bond, bill, account, note or in any other way and manner whatsoever and all interest due in respect thereof and to give, sign and execute all proper receipts, releases and discharges for the same respectively. **Power to Demand dues**
13. To execute all such bonds, guarantees, indemnities, covenants, deeds, assurances and obligations for and on behalf of the Corporation as the said attorney may think necessary or proper. **Power to execute bonds etc.**
14. To insure and keep insured against loss or damage by fire or otherwise for such period and to such extent all or any part of the land buildings, machinery, plants, materials, equipment and all other properties of the Corporation, movable or immovable either lying in the godowns, showrooms, or offices or in the workshops or factories or elsewhere or in transit in which the Corporation is interested whether as owner or by way of mortgage, pledge, hypothecate, charge or otherwise and to sell, assign, surrender or discontinue any of the insurances effected in pursuance of this power and also to receive moneys payable upon such policy and to give receipts and discharges for the same. **Power to take insurance.**
15. To take appropriate action and do things to comply with the requirements of any local law or any other regulatory statute and compound the offences by paying the fine in the interest of the Corporation. **Power to comply with local laws**
