Subject: Construction of 220 KV U/G Cable T/L at Hallomajra GIS Chandigarh.

Reference your letter No. N2MM/CHD/Forest/2018 dated 11.05.2018, on the subject cited above.

I am directed to inform you that the Competent Authority has accorded the final approval for the diversion of 0.1962 Ha. forest land in Dariya Reserved Forest Area near Vill. Makhanmajra, Nepli Range under Section-2 of the Forest (Conservation) Act, 1980 for the above mentioned work, subject to the following conditions:-

- i. The legal status of the forest land will remain unchanged.
- ii. As per proposal, no tree will be cut & removed.
- iii. The forest land will not be used for any other purpose than that of mentioned in the proposal.
- iv. The User Agency shall be bound to pay additional NPV amount, if the same is enhanced at any point of time.
- v. No damage of any kind will be caused to the adjoining forest & forest land and all efforts will be made to protect the forest & forest land.
- vi. The proposed Forest land for Diversion shall not be transferred/assigned in any manner to any other Agency, Department or Person without permission of the Forest Department, UT, Chandigarh
- vii. The lay out plan of the proposal will not be changed without permission of the Forest Department, UT, Chandigarh.
- viii. No Labour camp of any kind shall be allowed on the forest land.
- ix. As the forest land will be used underground, the dugout soil will be put in place after laying of the cable. The land shall be suitably leveled with the surrounding forest floor.
- x. The linear passage of the electric cable will be suitably demarcated on ground by cement pillars at suitable intervals in such a way that the forward and back pillars are visible.
- xi. The disposal of garbage will be carried out as per directions of the Forest Department, UT, Chandigarh.
- xii. Any other condition can be imposed by the Deptt. of Forests & Wildlife, U.T., Chandigarh, for the Conservation, Protection and Propagation of Forest & Wildlife from time to time.

The Forest Department, U.T., Chandigarh can suspend/cancel the approval, if the implementation of aforementioned conditions are not satisfactory.
