### MEMORANDUM:-

This department has given an "in principle" approval for Diversion of 0.0810 ha. Reserved Forest land for laying work Lathi-Liliya-Chavad upgradation regional water supply scheme covering 56 villages and 2 cities of Amreli District in favour of Executive Engineer, Gujarat Water Supply & Sewerage Board, Amreli, vide letter dated 25.04.2018 referred at Sr. No.(1) above.

The Nodal Officer (FCA), Gujarat has reported that the User Agency has deposited an amount of Rs.3,44,605/- towards the cost of CA + Rs.35,478/- towards the cost of NPV in Adhoc CAMPA, New Delhi by NEFT/RTGS(Challan) & Rs.7400/-Processing and Registration + Extra Fees is deposited in 8782 Forest Remittance referred at Sr. No. (1&2) above.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

1. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
3. Compensatory Afforestation is proposed at 1.00 ha forest land at S.No.579 pt, Village-Garadu, Tal. Zalod, Dist. Dahod. CA of mixed indigenous species will be raised and monoculture of species should be avoided. CA will be maintained for 10 years.

4. The User Agency will have to obtain permission from the Nodal Officer (FCA), for carrying out any maintenance works in future.
5. The user agency will have to restore the forest land after use/maintenance work. No trees are required to be cut in the demanded area
6. The User Agency will be liable to compensate any loss to Forests / Environment caused due to the use of the said land by the user agency.
7. The user agency will seek permission from the Roads & Buildings Department/Science and Technology Department, Sachivalaya, Gandhinagar, if required so.
8. The additional conditions under chapter-5 of Forest (Conservation) Act, 1980 shall be applicable to this proposal as the Government of Gujarat's Resolution No.FCA-1013/11-10/11/SF-24/F, Dated 12.06.2015. The user agency shall be bound to comply additional condition as per the aforementioned resolution. The project authority has submitted undertakings for the same.
9. Any other condition, which the Nodal officer (FCA) may stipulate from time to time.
