





The attention of the PCCF (WL) & CWLW, A.P., Mangalagiri, Guntur is invited to the references cited.

2. In the reference 1st cited, the Government of India, Ministry of Environment, Forests & Climate Change (WL-Division), New Delhi, have informed that "permits for underground laying of drinking water pipeline, Optical Fibre Cables and power lines upto 11 kv within the allowed Right of Way (Row) of roads inside National Parks, Wildlife Sanctuaries and Tiger Reserves or any other Protected Areas notified under the Wildlife (Protection) Act, 1972" may be granted by the Chief Wild Life Warden after recommendation of State Boards for Wildlife and approval of State / UT Governments, without these proposals being referred for consideration of the Standing Committee of the National Board for Wild Life, subject to certain conditions stipulated therein.

3. In the reference 3rd cited the PCCF (WL) & CWLW, A.P., Mangalagiri, Guntur, has informed that the subject proposal has been placed before the State Board for Wild Life for its approval. After deliberations, the Board has approved the proposal and directed the Chief Wild Life Warden to take further action in the matter. Accordingly, the PCCF (WL) & CWLW has requested to issue necessary orders in this regard.

4. In view of the above and as per the powers delegated by the Standing Committee of National Board for Wild Life and the approval of State Board for Wild Life, the Government hereby recommend the proposal under Wildlife (Protection) Act, 1972, for "use of 0.15 ha of forest land in Compartment No.83, Pasuvemula RF, Nagulavaram Beat, VP South Section & Compt.No.77, Kandlakunta RF, Koppunuru Beat, VP South Section of VP South Range of Project Tiger, Markapur of Palnadu District falls in Buffer area of NSTR and part of Rajiv Gandhi Wildlife Sanctuary for laying of OFC along the road for providing 4G Communication to the nearby villages in favour of M/s Reliance Jio Infocomm. Ltd., Visakhapatnam, subject to the following conditions:

- i. The size of the trench will not exceed more than 2.0 m depth and 1.0 m width;
- ii. The User Agency should not resort to the excavation of the surrounding forest land for collection of the earth to be used. If such excavation is found during the work period or later, the User Agency will be charged with suitable Provisions of the relevant Acts;
- iii. The User Agency agrees to make good any loss to forest/environment;
- iv. The User Agency agrees to make good the land after use/maintenance;
- v. The User Agency should inform the commencement of the work in the diversion area and execute the works under the supervision of the Forest Department;

- vi. The User Agency shall ensure that the length of the trench dug at a time does not exceed 500 m which shall be filled up and compacted before digging next stretch of 500 m;
- vii. The User Agency shall obey any other conditions stipulated by the Forest Department as per the Acts and Rules;
- viii. The User Agency shall carry out work only from dawn to dusk;
- ix. No labour camp shall be established in the Protected Area;
- x. The proposed area will be utilized only for the purpose for which the User Agency has sought it for, but not for any other commercial purpose;
- xi. No civil structures will be built with the underground laying of Optical Fiber Cable;
- xii. The User Agency will have to submit NOC from the agency which holds the right to use the Right of Way (RoW);
- xiii. The User Agency seeks permission from the State Forest Department for carrying out any maintenance;
- xiv. The User Agency will be solely responsible for any violation which attracts the Provisions of Andhra Pradesh Forest Act, 1967, Wild Life (Protection) Act, 1972 and Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 as amended from time to time;

5. The Principal Chief Conservator of Forests (WL) & CWLW, A.P., Mangalagiri, Guntur Dist., is requested to take necessary action in the matter accordingly.
