It is to inform that, the Government of India in the reference 1st cited have accorded in-principle (*Stage-I*) approval for diversion of forest land over an extent of 0.11 ha falling in Compartment no.973, K.Polavaram Shelterbelt forest block of Yellamanchili Range, Visakhapatnam Division in favour of M/s. Avanti Feeds Ltd., Visakhapatnam for laying underground pipeline from Shrimp hatchery to Bay of Bengal to draw sea water for hatchery subject to fulfillment of certain conditions laid down therein.

Accordingly the Conservator of Forests, Visakhapatnam Circle, Visakhapatnam in the reference 3rd cited has submitted the compliance on the conditions stipulated in the Stage –I approval accorded by the GoI, MoEF &CC, IRO, Vijayawada in the reference 1st cited.
