It is to inform that, Government in the reference 1<sup>st</sup> cited have conveyed  
Stage-1 approval for diversion of **1.79 ha** of Forest land in Prakasam (erstwhile  
Giddalur) Division for upgradation of NH-167 B from Km.86/540 to Km 87/340 i.e  
**Porumamilla to Chandrasekharapuram** to two lanes paved shoulders under  
NHDP-IV in the State of Andhra in favor of Executive Engineer (R&B), NH Division,  
Kadapa duly requesting to furnish compliance report on conditions stipulated  
therein.

In this regard, based on the reports furnished by the Chief Conservator of  
Forests/Conservator of Forests, Guntur in the reference 4<sup>th</sup> and 5<sup>th</sup> cited the  
following compliance report is submitted hereunder as detailed below.

Further the Divisional Forest officer, Prakasham has sent the copy of extracts of Stage-I orders published in Telugu & English Daily news papers so as to make aware of the permission granted to the project proponent for use of forest land for non-forestry purpose and the copies of Forest Clearance was submitted to local bodies, Panchayat for displaying the same in their offices for 30 days.

It is further submitted that, at the time of issue of Stage-I approval by the State Government vide reference 1st cited i.e., G.O.Ms.No.133, EFS&T (Sec.II) Dept, dt.30.11.2018, the proposed area for laying road in Giddalur division falls in LWE district and hence the State Government has accorded Stage-I approval under General Approval Category. The CCF, Guntur has not accorded working permission till date. As per the latest guidelines issued by GoI, MOEF&CC dt.29.12.2023 at sub para No. 2 of S.O 5074 ( E) of Para No. 4.1 of Chapter -4 of Van (Sanrakshan Evam Samvardhan) Adhiniyam rules 2023, **such districts that were earlier notified as Left Wing Extremism District but subsequently, their Left Wing Extremism District Status, on or before the date of handing over the forest land to the user agency, has been withdrawn, shall not be eligible for the exemption.** Hence, the Stage-I approval issued by the State Government vide reference 1st cited needs to be examined in the above lines for taking necessary action.
