Further the Divisional Forest officer, Chintapalli has reported that, User agency has deposited **Rs.0.10 lakh** towards tree extraction charges to the DFO, Narsipatnam (erstwhile) through DD No.351558, Andhra Bank, Visakhapatnam and the User agency has published the entire forest clearances granted in verbatim along with the conditions and safeguards imposed by the Central Government has been published in Telugu & English Daily news papers so as to make aware of the permission granted to the project proponent for use of forest land for non-forestry purposes and the copies of Forest Clearance was submitted to local bodies, Panchayats for displaying the same in their offices for 30 days

The Government are therefore requested to accord Stage -II (final) approval to the subject proposal at the earliest.
