It is to inform that the Government of India in the reference 1st cited, have accorded in-principle (*Stage-I*) approval for diversion of 18.86 ha (i.e., 11.49 ha in Madinapadu RF & 7.37 ha in Janapadu RF) of forest land for laying 765 KV D/C Warangal - Chilakaluripeta Transmission line implemented by Warora Kurnool Transmission Line (WKTL) subject to fulfillment of certain conditions laid down therein.

Accordingly, the Conservator of Forests, Guntur in the reference 3rd cited has submitted the compliance on the conditions stipulated in the Stage-I approval accorded by the GoI, MoEF & CC, RO, Chennai in the reference 1st cited.

In case it needs a revision, then a fresh demand notice may issued to the user agency for uploading it online. Accordingly, the District Forest Officer, Guntur has submitted the revised CA Scheme proposal with current FSR of 2021-22 of Guntur circle vide ref.6th cited for approval. Based on the proposals submitted by the District Forest Officer, Guntur the CA Scheme is approved and communicated for raising demand notice to the user agency vide ref.7th cited.

It is submitted that in the reference 1st cited, the Government of India has accorded In – Principle (Stage – I) approval for **diversion of 18.86 Ha(i.e., 11.49 Ha in Madinapadu RF & 7.37 Ha in Janapadu RF) of forest land for laying of 765 KV D/C Warangal – Chilakaluripeta Transmission line implemented by Warora Kurnool Transmission Line (WKTL)** subject to fulfillment of certain conditions laid down there in.

In the reference 2nd & 4th cited, a demand notice was issued to the User Agency to deposit the amount in the CAMPA account and submit the payment details along with condition wise compliance report laid down by the Government. But even after a lapse of more than two years, the user agency has not paid any amount and not submitted compliance report in the matter.

In the reference 5th cited, the Prl., Chief Conservator of Forests, A.P, Guntur and Conservator of Forests, Guntur Circle, Guntur have requested to submit report on whether the approved CA scheme to an amount of Rs.217.539 lakh and Rs.27.00 lakh for Raising & Maint. of SMM & Dwarf Species of the subject proposal needs to be revised

as per the present FSR rates or not for taking further action. In case it needs a revision, then a fresh demand notice may be issued to the user agency for uploading it online.

In view of the above, it is submitted that there is a necessity for revision of CA Scheme as per the current FSR. Accordingly, a revised CA scheme is prepared with a financial outlay of **Rs.273.078 lakh** and got it approved from the Conservator of Forests, Guntur. After receipt of the CA scheme approval from the Conservator of Forests, Guntur, this office has issued revised Demand Notice to the User Agency through the reference 7th cited duly requesting to take an appropriate action for depositing the amount and submitting the condition wise compliance report at the earliest.

Hence, it is requested to address the Prl., Chief Conservator of Forests, A.P, Guntur to withdraw the previous demand notice and consider the present revised demand notice, so as to pay an amount of **Rs. 355.685 lakh** (including NPV) by the user agency at the earliest.
