

against diversion of forest land on which Golden Pagoda Buddhist religious site is located



Please refer your above cited letter dt. 25.4.2024 where this office has been asked to take necessary action on the stipulated condition No. 2(ix) of the IPA letter No.11/113/2022-FC-Part(i) dt. 15.5.2024 of Ministry and to furnish action taken report for onward submission to MoEF & CC, RO, Shillong.

The said condition No. 2(ix) of the IPA letter No.11/113/2022-FC-Part(i) dt. 15.5.2024 of the Ministry reads as under:

*"The State Government or Regional Officer Shillong shall take action under section 3A/3B of the Adhiniyam, 1980 and a report will be submitted to the Ministry at the time of submission of compliance of Stage-I. The Regional office shall further pursue the progress of the offences booked against the erring officers. Furthermore, the State Govt. shall take strict action against officials as per the report of the Committee as constituted vide letter dated 08.08.2023 in pursuance of the Hon'ble NGT dated 28.7.2023".*

In this connection, it is to bring to your kind notice that similar information had been asked by IRO Shillong from time to time which was replied by NO (FCA) Itanagar each time as shown below.

*Dose 12/24*

(i) The IRO Guwahati in one of its clarifications vide SN (i) of letter F. No. 3 AN C 081/2022-GHY/1822-1823 dt. 12.1.2022 enquired "as per the submitted proposal the proposed area is already broken. State Govt to provide what action has been taken by the State government in case of encroachment and whether it is a case of violation of F (C) Act, 1980 under 3 A or 3 B? If violation under 3B of FCA 1980 names of the officials responsible for the violation and detail action taken report".

The PCCF & NO (FCA) submitted its reply to the same vide No. For.14/cons/2020/1892-95 dt. 20.5.2022 along with Annexure I submitted by the UA.

(ii) The IRO Guwahati vide SN (i) of letter F. No. 3 AN C 081/2022-GHY/2584-2585 dt. 22.6.2022 again enquired "what action has been taken by the State Forest Department

*under the F (C) Act, 1980, Hon'ble Supreme Court order 1996 (Gadhavarman case). State Government to furnish the detail action taken report in the chronological order of the events".*

The APCCF & NO (FCA) submitted reply vide No. For.14/cons/2020/2434-37 dt. 26.4.2023 informing action taken in chronological order of the events.

(iii) The IRO Guwahati vide SN (1) of letter F. No. 3 AN C 081/2022-GHY/3954-55 dt. 16.5.2023 enquired "to clarify the delay in detection of offence by the State Forest Department and the action initiated against the Forest Department officials for the lapse"

The APCCF & NO (FCA), while enclosing Chief Conservator of Forests, Tezu letter No. EAC/ Cons-9/2020/1597-99 dt. 11.6.2023, submitted reply vide No. For.14/Cons/2020/ 4277-80 dt. 26.7.2023 informing that there was no delay in detection as the O/Rs dt. 10.2.2005 and dt. 19.4.2018 were drawn by concerned ROs at the time of occurrence of offence which was forwarded by concerned DFO to court for trial within reasonable time. The delay was due to the order dt. 29.3.2018 of Executive Magistrate informing that he was no longer empowered to take up trial cases and another case with CJM vide order dt. 29.8.2017 (probably typing mistake 29.8.2018) which had asked for specific notification of the Govt to proceed with the case. The action taken of charge-sheeting the then DFO holding the charge of Namsai FD during that time from 21.3.2005 to 17.6.2010 was also informed.

(iv) The IRO Guwahati vide SN (3) of letter F. No. 3 AN C 081/2022-GHY/4735-36 dt. 16.10.2023 enquired "whether the local officers have reported the matter ongoing encroachment and violation of this scale by a single entity to any of the higher offices at CCF/ PCCF level".

The APCCF & NO (FCA) vide his No. For.14/cons/2020/6420-23 dt. 7.12.2023 informed it was not reported to higher offices at CCF/PCCF level since the offence report was forwarded to Executive Magistrate / Judicial Magistrate First Class, Namsai as per usual practice.

Further, it is to also reiterate that ADC Namsai had initially requested the DFO Namsai on 18.9.2007 for diversion of forest land for Buddha Temple in offline mode vide his letter dt. 18.9.2007. Further correspondence by DC/ DFO, if any, is not available in this office records after that. Later, the proposal for diversion of 19.52 Ha in Part I was submitted by Deputy Commissioner, Namsai vide his letter No. NLM – 136/2019-20/659 (A) dt. 4.9.2019. It was forwarded by DFO Namsai vide his No. AND/66/ 2019/ Tech/6327 dt. 29.1.2020 to Chief Conservator of Forests, Eastern Arunachal Circle, Tezu which, in turn, was forwarded by CCF Tezu with Part III to PCCF & NO (FCA) vide No. EAC/Cons-9/2020/477-78 dt. 25.2.2020. The proposal was ultimately forwarded by PCCF & NO (FCA) to IRO Shillong vide No. For.14/Cons/2020/5354-57 dt. 27.12.2021.

Since no formal proposal had been submitted by UA before 2019 and construction on occupied/ encroached forest land was done without FC, so the present case of violation

comes under 1.16 Ex-post facto approval and penal provisions under Van (Sanrakshan Evar Samvardhan) Adhiniyam. The said 1.16 (i) (a) and (i) (b) is reproduced as below:

**1.16 Ex-post Facto approval and Penal Provisions:** Proposals seeking ex-post-facto approval of the Central Government under the Van (Sanrakshan Evar Samvardhan) Adhiniyam, 1980 are normally not to be entertained. The Central Government will not accord approval under the Act unless under exceptional circumstances that may justify the case. In such cases the Central Government shall ensure penalty from user agencies/ State as follows.

(i) ***In cases where the proposal under the Van (Sanrakshan Evar Samvardhan) Adhiniyam has not been submitted and forest land is diverted without FC***

(a) The diversion of forest land for non-forestry purposes without the prior approval of the competent authority in the State will be dealt under the provisions of Indian Forest Act, 1927 and other State Acts dealing with the conservation of forests by the State Government concerned. The land in question will not be considered as diverted under FCA 1980 and the status of the land shall continue to be forest.

(b) If the permission for use of forest land for non-forestry purposes have been granted by the State authority without the prior approval of the central government under section 2 of the Forest Conservation Act, 1980 then action under section 3A and/ or 3B of FC Act, as may be applicable, shall be taken against the authority causing the diversion. A report with full details of violation shall be submitted by the State Government on the recommendation of the Forest Department of the State to the Ministry of Environment, Forest and Climate Change, Govt of India, New Delhi and formal enquiry shall be conducted by the Regional Office of the MoEF&CC.

The act of drawing offence reports under the provisions of Indian Forest Act, 1927 and other State Acts as per 1.16 (i) (a) by the concerned ROs during 2005 and 2018 has been submitted/ proved by the DFO Namsai with copies of O/Rs with the proposal. The SN 10 of the format for submission of violation report submitted by DFO Namsai also clearly mentioned that no official was involved in abetment and offence report was drawn promptly by RFO and same was duly forwarded by DFO to Magistrate for trial (copy enclosed).

Since no permission had been granted by State FD without prior approval of the Central Government so the present case comes under 1.16 (i) (a) and not under 1.16 (i) (b) and no action under section 3A and/ or 3B of Van (Sanrakshan Evar Samvardhan) Adhiniyam is applicable as per my understanding, as far as forest department officials are concerned but may come under 3B (1) (a) for offence by any department of Government in 2009 (Tourism) and 2018 (RWD road) and 2020.

The present case also comes under the clause where the proposal under the Van (Sanrakshan Evar Samvardhan) Adhiniyam has not been submitted (submitted in 2019) and forest land was encroached and constructed upon without FC (in 2005 as per offence report).

The present case, cannot obviously, come under Rule 1.16 (ii) for proposal under consideration and forest land diverted before grant of FC or under 1.16 (iii) for violation/non-compliance of any conditions imposed while granting approval or 1.16 (iv) for violation on account of change of land use but may, perhaps, come under 1.16 (v) where violation is not attributable to the UA since it may be a late entrant to the proposal.

The Section 3A and 3 B of the Adhiniyam, 1980 reads as under:

**3A. Penalty for contravention –**

*Whoever contravenes or abets the contravention of any of the provisions of section 2, shall be punishable with simple imprisonment for a period, which may extend to fifteen days.*

**3B. Offences by the Authorities and Government Departments –**

**(1) Where any offence under this Act has been committed –**

- (a) *By any department of Government, the head of the department, or*
- (b) *by any authority, every person who, at the time the offence was committed, was directly in charge of, and was responsible to, the authority for the conduct of the business of the authority as well as the authority;*

*shall be deemed to be guilty of the offence and shall be liable to be proceeded against and punished accordingly:*

*Provided that nothing contained in this sub-section shall render the head of the department or any person referred to in clause (b), liable to any punishment if he proves that the offence was committed without his knowledge or that he exercised all due diligence to prevent the commission of such offence.*

**(2)** *Notwithstanding anything contained in sub-section (1), where an offence punishable under the Act has been committed by a department of the Government or any authority referred to in clause (b) of sub-section (1) and it is proved that the offence has been committed with the consent or connivance of, or is attributable to any neglect on the part of the officer, other than the head of the department, or in the case of an authority, any person other than the persons referred to in clause (b) of sub-section (1), such officer or persons shall also be deemed to be guilty of that offence and shall be liable to be prosecuted against and punished accordingly.*

As per this office records, the area was cleared by one Shri Shiv Shankar Dutta, in 2005 who had been engaged by people of Theravada sect for construction of Buddha temple. An offence report dt. 10.2.2005 for encroachment in RF was filed under section 25 (d) of AFR Act, 1891 by the then concerned RO which was forwarded by the then DFO to magistrate for trial. The construction of such Buddha temple, however, perhaps continued after 2005-06 when ADC Namsai, through a letter dt. 18.9.2007, requested DFO Namsai for diversion of land for Buddha temple. No further correspondence after 2007 between DFO and ADC Namsai is available in this office records but the construction of Buddha temple complex perhaps still continued from 2005 to 2010 as Google **Wikipedia shows Temple complex of 20 Ha opened in 2010**. The then DFO Namsai from 2005 to 2010 was charge-sheeted and a

departmental enquiry was instituted as per rules and further action against any other Forest Department officials does not appear to have been taken as per this office records.

From above, it will be clear that the initial encroachment/ construction, at least till 2009, was done by private persons and not by any department of the government or authority so section 3A or 3B against any department or authority was perhaps not invoked. However, ~~the~~ for the works sanctioned in 2009, 2016, 2018 and 2020 by HoDs of Tourism, RWD and PWD will need to be prosecuted under 3B (1) while the works of 2021 and 2022 were anyway stopped, but offence report against Executive Engineer had been filed in 2018 under relevant sections of IFA and other State laws for road construction.

Now it may not be possible to find out officers/ persons responsible for violation of FCA, 1980 in 2005 (first encroachment of 19.5 Ha) till 2010 (when temple complex of 20 Ha opened up as per Wikipedia) or thereafter till 2018 (when road construction was done in the already encroached area) or till 2019 (when FCA proposal for 19.5 Ha submitted by DC Namsai), so kindly guide and advise to:


- (a) find out names of persons/ officials of Theravada sect who had engaged Shri Shiv-Shankar Dutta, in 2005 for construction of Buddha temple till around 2009-10 when temple opened up.
- (b) find out names of officials who had constructed the Buddha temple complex somewhere between 2005 and 2010 when it was opened to public as per Wikipedia.
- (c) find out names of officials of UA/Tourism Deptt/ PWD/RWD who had authorized for Buddha temple complex from around 2010 to 2018-19.

Further, a detailed report as asked from this office has been submitted vide No. EAC/ Cons-359/2023/3150-53 dt. 2.11.2023 to the Committee constituted by PCCF Itanagar vide letter dt. 8.8.2023 in pursuance to Hon'ble NGT order dt. 28.7.2023 and in view of above deliberations, my report highlighting the sequence of events is also enclosed for necessary action please.



## DETAILS OF THE CASE

While carrying out patrolling in Manabhum Reserve Forest near Tengapani Area in compartment No. 66 & 67, it was found that some labourers duly engaged by one Shri Shiv Shankar Dutta were clearing the area for renovation of old Buddhist temple. The works were immediately stopped.

On enquiry, Shri Shiv Shankar Dutta revealed that he has engaged the labourers on behalf of Tai Khamti Heritage Society and that the area is very sacred and of utmost religious importance to Tai Khamti Society as per the prediction of Buddhist monk of very high order.

Accordingly, Offence Report was drawn vide O.R. No. MBR/01 of 2004-05 dtd. 10.02.2005 and was forwarded to Divisional Forest Officer, Namsai Forest Division, Namsai.

The Divisional Forest Officer, Namsai vide his letter No. AND/16/2001/3478-79 dtd. 23.03.2005 forwarded the offence report to Addl. Deputy Commissioner cum Magistrate, Namsai for prosecution.

In view of total encroached area of 19.52 Ha. together with its entire complex the following is proposed.

Vide letter No. FOR.14/Cons/2020/5354-57 dtd. 22.12.2021 at  
SN 4 – Density = 0.1

SN 5 – NPV – 19.52 Ha. X 6.26 lakh/Ha. = Rs. 1,22,19,520/-  
5 times = Rs. 1,22,19,520/- x 5 = Rs. 6,10,97,600/-

In terms of 2 (b) it is 20% of the amount calculated,

Therefore, - Rs. 6,10,97,600/- x 20% = Rs. 1,22,19,520/- + 12%

**REPORT IN TERMS OF CONDITION No. 2(IX) OF THE IPA LETTER**  
**NO.11/113/2022-FC-Part(i) dt. 15.5.2024 OF THE MINISTRY**

The condition No. 2(ix) of the IPA letter No.11/113/2022-FC-Part(i) dt. 15.5.2024 of the Ministry has asked the following information which is being broken into following three components for the sake of clarity.

- a) *"The State Government or Regional Officer Shillong shall take action under section 3A/3B of the Adhiniyam, 1980 and a report will be submitted to the Ministry at the time of submission of compliance of Stage-I.*
- b) *The Regional office shall further pursue the progress of the offences booked against the erring officers.*
- c) *Furthermore, the State Govt. shall take strict action against officials as per the report of the Committee as constituted vide letter dated 08.08.2023 in pursuance of the Hon'ble NGT dated 28.7.2023".*

The report in terms with above three components is given below:

- (a) The State Government or Regional Officer Shillong shall take action under section 3A/ 3B of the Adhiniyam, 1980 and a report will be submitted to the Ministry at the time of submission of compliance of Stage-I.
  - (i) The area of 19.5 Ha/ 20 Ha was cleared by one Shri Shiv Shankar Dutta, in 2005 who had been engaged by people of Theravada sect to build a Buddha temple. An offence report dt. 10.2.2005 for encroachment in RF was filed under section 25 (d) of AFR Act, 1891 against a private person by the then concerned RO which was forwarded by the then DFO to magistrate for trial.
  - (ii) But the construction of such Buddha temple perhaps continued after 2005-06 by the offender when ADC Namsai through a letter dt. 18.9.2007 forwarded an application of a spiritual leader to DFO Namsai requesting for allowing puja in Buddha temple.
  - (iii) The constructions in the temple complex continued from 2005 and completed in 2010 which is evident from the fact on Google Wikipedia which shows that the Golden Pagoda Temple opened to public in 2010.
  - (iv) Further constructions for the temple complex in the encroached area where O/R had already been drawn also perhaps continued and completed from 2010 to 2017-18 with little or no resistance from forest Department except for the O/R of 2005 and a road was also constructed in the temple complex in 2018 for which another O/R dt. 19.4.2018 was drawn by the Forest Department against PWD.
  - (v) Much later, the proposal for diversion of 19.52 Ha in Part I was submitted by Deputy Commissioner, Namsai vide his letter No. NLM – 136/2019-20/659 (A) dt. 4.9.2019 where the breakup of all structures like monks quarters, vipasna, eco huts etc with their respective areas was mentioned which proves that these were already constructed before 2019 before submission of actual FCA proposal in 2019 by DC and thus it is a violation under 1.16 (i) (a).

- (vi) It had been clarified earlier that there was no delay in detection as the O/Rs dt. 10.2.2005 and dt. 19.4.2018 were drawn by concerned ROs at the time of occurrence of offence which was forwarded by concerned DFO to court for trial. The delay was perhaps due to the order dt. 29.8.2017 of CJM which had asked for a specific notification of the Govt to proceed with case and letter dt. 29.3.2018 of Executive Magistrate informing being no longer empowered to take up trial cases.
- (vii) As regards action initiated against Forest Department officials for any lapse, it had been clarified vide this office earlier letter No. No. EAC/Cons-9/2020/1597-99 dt. 11.6.2023 that a committee under the chairmanship of CF (Monitoring & Evaluation), O/o PCCF Itanagar was constituted by APCCF (RE) vide No. FOR.352/PRO/2012/ 15590-96 dt 16.6.2015 to examine the matter of large-scale encroachment/ deforestation in Manabhum RF/ Namsai Division and to find out names of officials in whose tenure illegalities had taken place. As per oblique reference found in file, the committee had submitted its report to APCCF (RE) on 8.9.2015.
- (viii) Further, it was also informed that another Committee under the chairmanship of PCCF (P&D) was again constituted by PCCF & Prl.Secy (E&F) vide No. FOR.352/PRO/2012/10,238-41 dt 10.5.2016 to examine large scale encroachment in Manabhum RF. The chairman of the committee submitted its report to PCCF & Prl.Secy (E&F) on 30.8.2016. Although, no charge sheet is available in this office records, but as per letter No. FOR/CC-1/07/2018/834 dt. 21.5.2018, Shri T. Pertin, the then DFO Namsai was charge sheeted in the matter of large-scale encroachment in Namsai Forest Division.
- (ix) Since the then DFO Namsai was charge-sheeted and a departmental enquiry was instituted as per rules so no further action appears to have been taken.
- (x) In view of above, as per this office records, no action seems to have been taken against private person, Shri Shiv Shankar Dutta, except filing of O/R dt. 10.2.2005 and no action seems to have been taken against govt department/ agency/ Tourism/ RWD/ PWD except filing of O/R dt. 19.4.2018 while the then DFO Namsai from 2005 to 2010 was charge sheeted by PCCF.

**(b) The Regional office shall further pursue the progress of the offences booked against the erring officers.**

- (i) As per reports submitted by DFO Namsai, the offence report dt. 10.2.2005 was drawn against Shri Shiv Shankar Dutta who was found on the spot in Golden Pagoda area in 2005 by forest officials and who had cleared the area. The said O/R dt. 10.2.2005 against the private person was forwarded by DFO Namsai to ADC Namsai for trial/ prosecution vide No. AND/16/2001/3478-79 dt. 23.3.2005.
- (ii) Much later, another O/R dt. 19.4.2018, was again drawn against Executive Engineer PWD when a construction of pucca road was again detected within the same area of 19.5 Ha which was forwarded by DFO Namsai to Court for trial.
- (iii) In view of above, it is established that the offence of encroachment had initially been done in 2005 and construction of road in the already encroached area in 2018 as per offence reports submitted in Court by the DFO Namsai. So, the matter is

perhaps still subjudice as per law but with creation of Namsai District in 2014 the chances of the O/Rs being still traceable is bleak. Moreover, 3B (1) (b) also states "***every person who, at the time the offence was committed***" so the chances of the person of that Govt Deptt/ HoD at the time of commission of offence in 2009, 2016, 2018, 2020 etc being still alive/ in service are less but DFO Namsai should identify such persons of Tourism/ RWD/ PWD and take action against them.

(iv) A sequence of events is also being given below to identify every person who were there at the time of the offence was committed.

- (v) However, the O/R dt. 19.4.2018 of 2018 against PWD for construction of road and O/R dt. 10.2.2005 against Shri Shiv Shankar Dutta also needs to be pursued in court for which the DFO Namsai is being directed.
- (vi) Similarly, the three time zones can be defined for the officials of the Forest Department most of whom also share the same fate of either not being alive or superannuated as shown below.

( c) Furthermore, the State Govt. shall take strict action against officials as per the report of the Committee as constituted vide letter dated 08.08.2023 in pursuance of the Hon'ble NGT dated 28.7.2023.

- (i) As regards, the Committee as constituted by PCCF Itanagar vide letter dated 08.08.2023 in pursuance of the Hon'ble NGT order dated 28.7.2023, it is to mention that a detailed report running into 13 pages with 7 pages enclosure has been submitted to the Chairman of the Committee vide this office letter No. EAC/Cons-359/2023/3150-53 dt. 2.11.2023 highlighting the sequence of events, the timelines and the names of DFOs/ CFs/ CCFs etc at that time when the events took place.
- (ii) It is not known to this office if the said Committee has since submitted its report to PCCF & HoFF.
- (iii) Kindly advise next course of action required to be taken from this office as per names and periods of officers mentioned in the report submitted vide No. EAC/Cons-359/2023/3150-53 dt. 2.11.2023.

As per SN 2,3,4,6 and 7 in Table 1 and the chronology mentioned above, the lack of action and/ or inaction by UA/ RWD/ PWD/ Tourism and FD is evident during following periods.

In this connection, the DC Namsai/ UA letter No. NLM-136/2019-20/8260-62 dt. 24.11.2023 may be referred which had been forwarded by NO (FCA) Itanagar to IRO- Gauhati vide No. For.14/Cons/2020/6420-23 dt. 7.12.2023 wherein the detailed project report on Golden Pagoda with photographs of existing facilities consisting of P-1 to P-15 had been submitted by DC Namsai duly signed, besides others. The funding by State govt had also been enclosed by him showing the following.



From the above tables, it is clear that constructions in Golden Pagoda started around 2005 and completed in 2010 and the govt also funded some projects after 2009 through Tourism/ RWD/ PWD. The DFO Namsai vide SN 1 of his letter No. AND/66/2019/Tech/ 9289 dt. 25.11.2023 has said that these were not reported by DFO to higher offices at CCF/ PCCF level. On enquiry by IRO Guwahati vide letter F. No. 3 AN C 081/2022-GHY/4735-36 dt. 16.10.2023 whether the local officers have reported the matter ongoing encroachment and violation of this scale by a single entity to any of the higher offices at CCF/ PCCF level, the APCCF & NO (FCA) vide his No. For.14/Cons/2020/6420-23 dt. 7.12.2023 has also informed IRO that it was not reported to higher offices at CCF/ PCCF level. Thus, following inference can be deduced.

- (i) Since disciplinary action against then DFO Namsai from 2005 to 2010 had already been initiated by PCCF so no further action was taken against forest department officials.
- (ii) The proposal for diversion of 19.52 Ha in Part I was submitted by Deputy Commissioner, Namsai vide his letter No. NLM – 136/2019-20/659 (A) dt. 4.9.2019 but the matter of encroachment was hidden when DFO Namsai while forwarding the proposal first time vide No. No. AND/66/ 2019/ Tech/6327 dt. 29.1.2020 at SN 9 of Part II mentioned “no violation” which was forwarded by PCCF & NO (FCA) to IRO Shillong also mentioning no violation at SN of 14 of letter No. For.14/ Cons/2020/5354-57 dt. 27.12.2021.
- (iii) The violation was first time reported by CCF vide No. EAC/Cons-9/2020/1207-08 dt. 2.4.2022 and so the last two works at SN 4 and 5 got stopped.
- (iv) The NO (FCA) vide his letter No. For.14/Cons/2020/1892-95 dt. 20.5.2022 addressed to IRO informed the component wise constructed break-up of area while DFO again informed the same vide No. AND/66/2019/Tech/9289 dt. 25.11.2023 which shows that component wise construction was done/ completed before 2020.

- (v) Though Golden Pagoda falls under Manabhum Range but it is in very close proximity to other Range Offices also and the chances of construction activity from 2005 to 2010 and thereafter from 2011 to 2018-20 going un-noticed is bleak.
- (vi) The incumbency chart of RO Manabhum (about 20 km away), RO Tengapani (about 100 meters away) and RO Chowkham (about 15 km away) from the site is appended with report for perusal and suitable decision.
- (vii) The matter of ongoing encroachment and violation of this scale was not reported by DFO/ ROs to higher offices at CCF/ PCCF level as per SN 1 of DFO Namsai letter No. AND/66/2019/Tech/9289 dt. 25.11.2023 and APCCF & NO (FCA) vide his No. For.14/Cons/2020/6420-23 dt. 7.12.2023.
- (viii) Since no proposal had been submitted by UA before 2019 and construction on occupied/ encroached forest land was done without FC, so the present case of violation comes under 1.16 (i) (a).
- (ix) Since no permission had been granted by State Forest Department without prior approval of the Central Government so the present case will not come under 1.16 (i) (b) therefore no action under section 3A and/ or 3B of Van (Sanrakshan Eevam Samvardhan) Adhiniyam can be invoked against forest officials of Namsai FD.
- (x) The works sanctioned in 2009, 2016, 2018 (road) and 2020 by HoDs of RWD and PWD will need to be prosecuted under 3B while the works of 2021 and 2022 stopped when they came into knowledge of FD.
- (xi) The O/R dt. 10.2.2005 against Shri Shiv Shankar Dutta and O/R dt. 19.4.2018 of 2018 against PWD for construction of road will be pursued in court by DFO Namsai.
- (xii) Strict action will be taken by State Govt against officials found responsible as per Committee report constituted by PCCF Itanagar vide letter dated 08.08.2023.



With reference to your letter no I am furnishing herewith the details for the matter as point wise as sought by the APCCF (CONS) & NO (FCA) Itanagar.

- 1) S.N 2(ii) (b)- C.A scheme on degraded forest land for four (4) times area of the land proposed for diversion as per guidelines 2023. 78.08 ha area is identified at Khamang RFand scheme has been submitted for approval.
- 2) S.N 2(ii) (d) – The compensatory afforestation on degraded Forest land,4 times in extent to the Forest land being diverted i.e. 78.08 ha, shall be raised by the state Forest Department at the project cost within three years from the date of grant of stage-II approval. Final approval is awaited to carry out the compensatory afforestation as compensatory levies has been deposited by the user agency.
- 3) S.N 2(ii) (e) – 25% of CA cost towards soil and moisture conservation activities in the proposed CA area as per site requirement has been deposited by the user agency. The required activities will be carried out after the final approval.
- 4) S.N (xii) – All encroachment on the notified forest land shall be removed in a phased manner while following the extent rehabilitation and re-settlement policy. In this regard matter is in discussion with the higher authorities and placed in the state level for further course of action. In this regard an undertaking is submitted as annexure-1
- 5) S.N (xv) – The KML files of the diverted area, C.A area and the proposed SMC treatment area is uploaded on the e-green watch portal with all requisite details.
