A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

1	The User Agency shall transfer online, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in IA No.566 in WP (C) No. 202/1995 and as per the guideline issued by the Ministry vide letter No. 5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online portal into the CAMPA account of the State concerned.	The amount of Net Present Value of the forest land diverted under this proposal for Rs. 2,31,01,278/- has been deposited to National Authority (CAMPA) as per e-challan dated 23.12.2021 and deposited on 27.12.2021 at Annexure-I.
2	The User Agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of the concerned State through online portal. The KML files of the area to be diverted, the CA areas are uploaded on the e-Green watch portal. The CAT plan and WLMP are not related to this project.
5	The boundary of the diverted forest land, mining lease and safety zone, as applicable, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from the pillar to pillar and GPS co-ordinates as per the directions of the concerned Divisional Forest Officer.	The User Agency has submitted undertaking for this condition at Annexure-II.
6	The user agency shall explore the possibility of successful translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department. 7	The charges for felling, logging and transportation of project affected trees should be collected from the User Agency at the rates approved by the State Govt and deposited with the DFO concerned for utilization immediately following the diversion of forest land.	An amount of Rs. 4,37,836/- towards cost of felling, logging and transportation of project affected trees of the land proposed for diversion has been deposited directly to the Divisional Forest Officers, Banderdewa & Sagalee FD.
8	The expenditure like boundary walls, stone pillars, demarcation charges, cost of damage of trees the funds on these accounts should, be deposited with the DFO concerned	The User Agency has submitted undertaking for this condition at Annexure-IV.
9	The user agency shall restrict the felling of trees to the minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest	The User Agency has submitted undertaking for this condition at Annexure-V.

11	Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act,1980 as issued by this Ministry's letter No. 5-2/2017-FC dated 28.03.2019.	The User Agency has submitted undertaking for this condition at Annexure-VII.
12	The User Agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line for execution of the said scheme to the State Forest Department.	The scheme for dwarf species plantation has been prepared and sent to IRO, Guwahati with the diversion proposal.
13	The compliance report shall be uploaded on e-portal (https://parivesh.nic.in).	Noted

B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Statge-II approval:

1	Legal status of the forest land shall remain unchanged.	Noted.
2	The Compensatory Afforestation shall be taken up on over double the degraded forest land of 49.502 ha identified in two patches i.e 30.00 ha in Banderdewa Forest Division and 19.50 ha in Sagalee Forest Division in Doimukh Reserve Forest, Papum Pare District within three years from the date of Stagfe-II Clearance and maintained thereafter by the State Forest Department at the cost of the User Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided. The CA will be maintained for 10 years.	Noted.
3	The proposed OB labour Sheds & OB hut in the Compensatory Afforestation scheme should be of temporary structure and to be dismantled within 10 years from the 1 st year of plantation, State Govt shall adhered to Section 5(4) (e) of CAF rules and other	Noted.

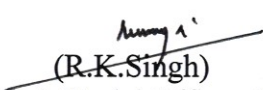

5	The User Agency shall obtain the Not Environment Clearance as per the provisions of Environment (Protection) Act, 1986, if required;	Not applicable.
6	No labour camps shall be established on the forest land and the User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas. 7	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt of India.	The User Agency has submitted undertaking for this condition at Annexure-X.

12	The User Agency shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project. 13	The User Agency shall comply with the guidelines for transmission line through forest areas issued by Ministry vide letter No.	The User Agency has submitted undertaking for this condition at Annexure-XV.

18	Any other conditions that the North Eastern Regional Office, Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of Forests & Wildlife.	Noted

It is, therefore, requested to kindly issue necessary formal approval for diversion of 24.602 ha forestland for construction of above Transmission line under Section-2 of the Forest (Conservation) Act, 1980 at an early date.
