With reference to letter cited above, this is to submit compliance report as below of the conditions stipulated therein for favour of your information and necessary action:

A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

1	The User Agency shall transfer, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in Writ Petition (Civil) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online portal into CAMPA account of the State concerned. 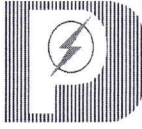

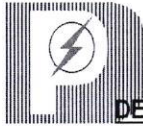



In compliance of the **Ministry of Environment and Forests (MoEF)** Government of India's **Letter No.11-9/98-FC [pt]** dtd 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the **Scheduled Tribes and other Traditional Forest Dwellers [Recognition of Forest Rights] Act, 2006** ['FRA' for short] on the land proposed to be diverted for non forest purpose read with MoEF's letter dated 5th Feb' 2013 & PCCF [A&V] Nodal Officer, FCA, Govt.
