Sub:- Proposal for diversion of 45.8205 ha of forest land for laying of 33 KV Transmission Line from Namsai to Diyun under Comprehensive Scheme for strengthening of transmission and distribution system by Power Department in Namsai & Changlang District of Arunachal Pradesh

With reference to letter cited above, this is to submit compliance report as below of the conditions stipulated therein for favour of your information and necessary action:

**A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department.**

1	The User Agency shall transfer, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in Writ Petition (Civil) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online portal into CAMPA account of the State concerned.	The amount of Net Present Value of the forest land diverted under this proposal for Rs. 5,32,19,696/- has been deposited to National Authority (CAMPA) as per e-challan dated 29.03.2022 and deposited on 29.03.2022 at Annexure-I.
2	The User Agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. 6	The boundary of the diverted forest land, mining lease and safety zone, as applicable, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from the pillar to pillar and GPS co-ordinates as per the directions of the concerned Divisional Forest Officer.;	The User Agency has submitted undertaking for this condition at Annexure-II.
7	The User Agency shall explore the possibility of successful translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department. 8	The charges for felling, logging and transportation of project affected trees should be collected from the User Agency at the rates approved by the State Govt and deposited with the DFO concerned for utilization immediately following the diversion of forest land. 13	The User Agency in consultation with the State Forest Department preparae a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line for execution of the said scheme to the State Forest Department.	The scheme for dwarf species plantation has been prepared and sent to IRO, Guwahati with the diversion proposal.

**B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Statge-II approval:**

1	Legal status of the forest land shall remain unchanged.	Noted
2	The Compensatory Afforestation shall be taken up on double the degraded forest land i.e. 91.67 ha identified at 2 locations i.e. 23.22 ha at Diyun RF in Nampong Forest Division, Changlang District and 68.45 ha in Simen PRF in Likabali Forest Division in Lower Siang District of Arunachal Pradesh within three years from the date of Stage-II Clearancer and maintained thereafter by the State Forest Department at the cost of the User Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avaided. The CA will be maintained for 10 years.	Noted.
3	The proposed OB labour Sheds & MB type quarter in the Compensatory Afforestation scheme should be of temporary structure and to be dismantled within 10 years from the 1 <sup>st</sup> year of plantation, State Govt shall adhered to Section 5(4) (e) of CAF rules and other relevant Rules as applicable while	Noted.
