Compliance of the conditions laid down in the "In-Principle approval" for diversion of 1.779 Ha of Forest Land for drilling location KHBK in Rengma Reserve Forest under Golaghat division in favour of Oil & Natural Gas Ltd, Jorhat.

With reference to the above, I am directed to submit herewith the report regarding compliance of the conditions enlisted in the Central Government's "In-Principle Approval" issued vide letter No. No-3-AS B 095/2022-GHY/3151-3152 dated 27.10.2022 for the above-mentioned forest diversion proposal as given below:

Condition No. A	Compliance Report/Remarks
(1)	The User agency (ONGC Ltd.) has deposited Rs. 19,86,965/- for Net Present Value against forest land to be diverted.
(2)	The User agency (ONGC Ltd.) has deposited a total amount of Rs. 80,55,668/- into Ad-hoc CAMPA account through online web portal (www.parivesh.nic.in) of MoEF&CCon 07.02.2023(copy enclosed as Annexure -I). The details are as follows: Net Present Value = Rs. 19,86,965/- Compensatory Afforestation = Rs. 40,45,802/- Over Head Cost = Rs. 20,22,901/- Total Rs. 80,55,668/-
(3)	All the funds for CA, NPV and Overhead cost have been deposited to CAMPA account through e-portal.
(4)	The User Agency has uploaded the compliance report on e-portal.
(5)	The KML file of proposed diversion area and Compensatory Afforestation area are uploaded in Parivesh Portal.
(6)	The user agency has transferred through e payment an amount of Rs. 5400000/- against Elephant/Wildlife conflict mitigation & wildlife conservation plan, which was deposited on 28.06.2023.
(7)	The State Govt will ensure that the measures envisaged in Human Elephant/wildlife Conflict mitigation and wildlife conservation plan will be implemented within a period of 2 years to ensure commencement of rejuvenation of ecosystem services lost from the forest area allowed for non-forestry use of forest land.
(8)	A lump sum amount of 2% of total project cost towards the cost of implementation of the Wildlife Management Plan has been realized from the User agency and is being submitted along with the Stage I Compliance. The state govt will ensure that the finalized WLMP and payment of deficit amount, if any, will be intimated to the concerned IRO of the Ministry before actual breaking of the forest land.
(9)	The User agency (ONGC Ltd.) has submitted the FRA-2006 Certificate (Copy

	enclosed as Annexure-II)
(10)	The User agency (ONGC Ltd.) has obtained EC vide letter no. SEIAA.1294/2020/EC/1991 dated 17.02.2023 from State Environment Impact Assessment Authority (SEIAA), Guwahati.
(11)	The expenditure towards posting of boundary pillars for area demarcation has been deposited by the User Agency to the DFO, Golaghat Division. The certificate of the DFO, Golaghat Division verifying the demarcation of the boundary and fixing of boundary pillars on the proposed forest area is enclosed herewith as Annexure –III . The GPS Coordinate of the boundary pillar are enclosed herewith as Annexure – IV .
(12)	The User agency (ONGC Ltd.) has submitted undertaking for condition No (12) laid down in the “In Principle Approval” as Annexure- V
(13)	No conditions have been violated by the User Agency.

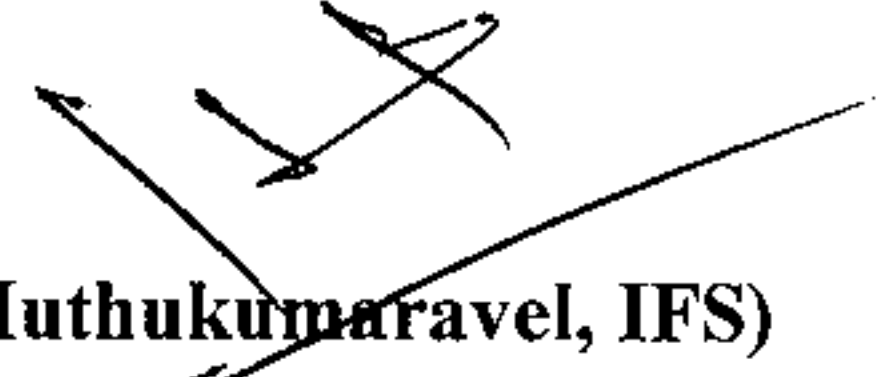
