6	The expenditure towards posting of boundary pillars for area demarcation has been deposited by the User Agency to the DFO, Sivasagar Division. The certificate of the DFO, Sivasagar Division verifying the demarcation of the boundary and fixing of boundary pillars on the proposed forest area is enclosed herewith.
7	The DFO, Sivasagar Division has stated that the no designated dumping site requires on the proposed area.
