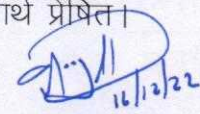

1. As per the scope of total 4609 nos. of trees, Concessionaire has translocated 1810 nos of trees & 94% of translocated trees i.e., 1702 nos of trees have survived.
2. Balance translocation of trees are in progress as per the Construction Schedule. Further, the progress is held up/slow down due to frequent heavy rainfall & water logging in the subject project.
