(185.017 है. राजस्व वन भूमि एवं 55.850 है. डिन्ड फारेस्ट) वन भूमि के गैर वानिकी उपयोग हेतु प्रथम चरण की स्वीकृति प्रदान की गई है जिसकी संसूचना छत्तीसगढ़ शासन, वन एवं जलवायु परिवर्तन विभाग के संदर्भ पत्र—2 द्वारा प्राप्त हुई है।
