The User Agency shall furnish an undertaking to this effect.	The undertaking has been submitted by the U.A. 8	The User agency shall seek permission from local Forest Department for carrying out any maintenance;	Agreed by U.A.
9	The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	Agreed by U.A.
10	The User Agency shall obtain the Environmental Clearance before issue the formal order.	Not applicable as stated by U.A.
11	All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed by U.A.

12	The User Agency shall transfer / deposit ₹ 3,42,597/- (Rupees : Three Lakh Forty Two Thousand Five Hundred Ninety Seven only) towards Compensatory Afforestation including maintenance for 10 years and ₹ 2,28,628/- (Rupees : Two Lakh Twenty Eight Thousand Six Hundred Twenty Eight only)	The Payment is transferred by to Ad-hoc CAMPA vide transaction NEFT / RTGS No. N240190911745006 dated 14.06.2019 may please be seen at page C/87.
