May kindly peruse the letter No. PWDIII/IRRI/DP/FC/2020/611 dated 29.06.2020 regarding proposal for diversion of 0.951 Ha. of reserved Forest land for Integrated Water Management Plan W.D - III for Khadoli, Tinoda and Bindrabin village in the U.T. of Dadra & Nagar Haveli, Silvassa.

The point wise compliance of the conditions of In-principle approval letter is as under:-

1	The legal status of the forest land shall remain unchanged i.e. shall remain Reserve / Protected / Village / other types of forests / forest as the case may be.	Agreed
2	No felling of tree shall be involved in the implementation of the proposal.	The project involves no felling of tree. Agreed
3	The maximum size of the trench shall not be more than 2.00 meter depth and 1.00 meter width.	Agreed
4	The pipeline shall be along the road within existing right of way not falling in National Parks and Wildlife Sanctuaries.	Agreed

The User Agency shall furnish an undertaking to this effect.	Agreed. The undertaking for the same is submitted herewith.
8	The User Agency shall seek the necessary clearance under Wildlife Protection Act, 1972 as the proposed project is passing through DNH Wildlife Sanctuary.	Not applicable.
9	The User agency shall seek permission from Forest Department, Dadra & Nagar Haveli for carrying out any maintenance;	Agreed
10	The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	The best possible and strict measures shall be taken to conserve the flora/fauna during construction.

11	All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed
12	It will be the responsibility of the User Agency to ensure that the labourers and staff engaged in construction activity do not damage forest flora and fauna.	Agreed
13	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Central Government	Agreed
14	Proposed labour camps outside the forest area to be dismantled and removed. The labourers shall be sent back immediately after the completion of work.	Agreed
15	All the fund received from the User Agency under the project shall be transferred to the CAMPA fund only through e.portal (http://forestclearance.nic.in)	The payment has been transferred towards the details mentioned in the challan generated from the website
16	The User Agency has to pay Rs. 11,91,172/- towards Compensatory Afforestation of land and Rs. 8,92,989/- towards Net Present Value including maintenance for 10 years.	The payment has been transferred towards the details mentioned in the challan generated from the website
17	The forest land shall not be used for any purpose other than that specified in the proposal.	Agreed
18	The Compliance report shall be uploaded on e.portal (http://forestclearance.nic.in)	Agreed
