PUC is the letter dated 09/12/2019 (at pg. 21/C) from Regional office, MoEF&CC, Bangalore regarding in-principle approval (Stage-I) under section 2 of Forest (Conservation) Act, 1980 for diversion of 0.06 ha. of forest land in Sy. No. 135 of Torxem village, North Goa Division for construction of existing NH-17 (New NH-66) from Km 475.000 to 502.500 in the State of Goa under NHDP-III (Patradevi to Karaswada Section) on NH-17) in favour of Public Work Department, WD-VII (NH), Panaji-Goa by stipulating certain conditions to be complied by the User Agency.
